BACKGROUND

The 918 Aeronca Lane lease agreement, a 31-year term commencing December 6, 1994, and expiring April 30, 2025, will revert to the City upon expiration. The City will subsequently lease the 6,080 square foot hangar on the .439-acre parcel at Fair Market Value.

DSR-Cherokee 180, LLC, current tenant of the City, seeks to acquire the hangar to accommodate additional aircraft for its flight school program. The proposed assignment will not involve any renegotiation of lease terms or conditions.
