SUBJECT

Consider a request by Sagebrook Denton LP for a Final Plat of the Sagebrook Addition, Phase 2. The approximately 9.5-acre site is generally located at the southwest corner of the Allred Road and South Bonnie Brae Street intersection, in the City of Denton, Denton County, Texas. (FP23-0028, Sagebrook Addition Phase 2, Ashley Ekstedt).

BACKGROUND

The purpose of this Final Plat is to establish the lot, easement, and right-of-way configuration for 42 residential lots and 1 open space lot. The subject property is zoned Planned Development (PD), and this final plat is intended to facilitate development of the second of four phases of a single-family residential subdivision. The proposed layout for Phase 2 is generally consistent with the development plan approved as part of the Planned Development.

This application is being considered under TX LGC 212.009. The applicant has requested a 30-day extension to allow for additional time to work through staff's comments on the plat and additional review (Exhibit 5). RECOMMENDATION
