SUBJECT: Committee Requested Project Updates

This memo provides information and updates from staff relating to updates to the Committee on items of interest discussed in past meetings. The following is a listing and brief staff response to the matters brought forward.

Economic Benefits on Bollards:

Implementing bollards in key locations throughout Denton can significantly enhance public safety and benefit local businesses. By preventing vehicle-related accidents, these protective measures create safer environments for pedestrians and cyclists, encouraging more visitors to local shops and events. Increased foot traffic can lead to higher sales and foster economic growth within the community. Furthermore, strategically placed bollards improve urban planning by clearly defining pedestrian and cycling zones, which can enhance property values and reduce maintenance costs. The aesthetically pleasing arrangement of bollards also contributes to a more attractive cityscape, helping to attract investment and new developments. Overall, effective bollard implementation drives long-term benefits for Denton.

Growing the Bike Bus Program:

During the April Mobility meeting, the committee requested Staff explore expanding the Bike Bus program currently at Newton Rayzor Elementary School. The Bike Bus program runs as a voluntary effort by the parents at the school. Staff will reach out to Alexander and Rivera Elementary School in the fall to explore potential interest for the Bike Bus program with the PTA at each school. Staff will facilitate and assist if necessary.

Hickory Creek Crossing Gate Evaluation:

During the January Mobility meeting, Committee Member Rumohr requested Staff explore a separate pedestrian crossing gates at the future US 377/Brush Creek/Hickory Creek Rail crossing intersection. Staff has discussed the possibility with the UPRR design consultant, and they will incorporate the exclusive pedestrian/bike gate configuration into the design at Brush Creek/US 377 intersection.

Nette Schultz Elementary School Intersection:

During the April Mobility meeting, Council Member Beck inquired about pedestrian safety at the Nette Schultz Elementary School intersections. Staff have plans to improve the markings, add no

parking restrictions, and add additional signage to improve the pedestrian crossings along E Windsor Drive before the school starts in the fall. These improvements should provide better visibility for vehicles to see crossing pedestrians at the intersections to safely stop ahead.

U.S. 380 Pedestrian Signal Position:

During the April Mobility meeting, Committee Member Rumohr requested to explore the Malone Street pedestrian signal indication position at the intersection. Staff audited the US 380 at Malone intersection and will be able to adjust the pedestrian indication display before the start of the new school year.

Revising Standard for Collector and Arterial Roads:

Revising the roadway functional classification is essential for improving transportation efficiency and safety. An updated classification will define the purpose of each roadway, enabling city staff to prioritize enhancements and allocate resources effectively, thereby boosting connectivity for vehicles, pedestrians, and cyclists. The revision of functional classifications can address issues such as traffic congestion and accessibility, adapting classifications to reflect recent or projected development patterns, including new categories like Stroads for a more integrated urban approach. The Transportation Services Division (TSD) proactively seeks to amend road classifications in response to development changes, such as adding a major collector for the East Windsor connection and changing a segment of Eagle Drive from an Arterial type to Collector type. The upcoming Mobility Plan update presents an opportunity for TSD staff to make comprehensive revisions. Engaging community stakeholders and conducting thorough data analysis will help improve classifications based on local traffic and safety concerns. By adopting a participatory approach, the staff can refine the roadway classifications and promote a sustainable transportation network that meets the diverse needs of the residents. Staff will continue assessing updates to the roadway classifications as development patterns evolve in Denton.
