
Funding presentations to the CSAC are scheduled to take place on February 25, 2023, and March 11, 2023.

Thank you for submitting a funding application to the Community Services Advisory Committee (CSAC) for the 2023-24 Community Development Grant Program funding year. Each applicant organization will make a presentation before the CSAC. Staff is requesting no more than two (2) representatives from each organization. Organizations will have five (5) minutes to make a presentation regarding your funding request. Committee members will have five (5) minutes to ask questions following your presentation.

It is requested that the representatives be either staff or board members who can respond to the funding application items, including Objectives, Program/Project Details, Community Need and Impact, Human Resource Information, and Financial Data. Presentations do not need to recap the application. Instead, applicants are encouraged to offer information on the organization, program data, strategic information, and funding goals NOT included in application.

Applicants who wish to make a PowerPoint presentation are asked to send it to Courtney Douangdara (Courtney.Douangdara@cityofdenton.com) two (2) business days prior to their presentation date. If the applicant would like to provide additional materials for CSAC members, they must also be sent two (2) days prior to the presentation date. Applicants will not be allowed to distribute handouts to the committee the day of their presentation.

Presentations will take place on February 25 and March 11. Please review the below schedules to confirm your presentation date and presenter. Representatives should arrive early in case the meeting runs ahead of schedule.
