### **SUBJECT**

Receive a report, hold a discussion, and provide recommendation to City Council regarding the approval of a Fourth Amendment to Airport Lease for Sheltair Aviation Denton, LLC covering property at 4849 Spartan Drive, Denton, Texas at the Denton Enterprise Airport; amending the existing airport lease; authorizing the City Manager to execute the Fourth Amendment of Airport Lease; and providing an effective date.

### **BACKGROUND**

The lease agreement with Sheltair Aviation Denton, LLC (“Lessee”) is a 35-year, and 4-month agreement dated and effective May 15, 1998, through March 11, 2049. The leasehold encompasses 1.48 acres and includes a 15,494 square foot building currently utilized for classroom space, aircraft storage, and aircraft maintenance.

The Lessee has requested an amendment to Section V to add vehicular parking as a permitted use on a portion of the lease where it is currently not permitted. The permitted vehicular parking will only be allowed to support the existing aeronautical uses within the lease and the parking surface must be constructed to a standard that would accommodate aircraft parking in the future. The vehicular parking use would be required to conform to any applicable Airport Minimum Operating Standards or other law or regulations.

The additional vehicular parking is designated to support the operational needs of a subtenant conducting a permitted aeronautical business at the Airport. This allocation is intended to fulfill the subtenant’s parking requirements and address increased capacity demands associated with their activities.

### **RECOMMENDATION**

Airport Staff recommends approval of the Fourth Amendment to Airport Lease (**Exhibit 3**)

### **FISCAL INFORMATION**

This property lease is for 1.48-acres of land for a current annual lease rate of \$30,321.02. The annual lease rate is subject to a Consumer Price Index for all urban consumers (CPI-U) increase, every year, with the next adjustment to occur on May 1, 2026.
