AN ORDINANCE OF THE CITY OF DENTON, A TEXAS HOME-RULE MUNICIPAL CORPORATION, AUTHORIZING THE APPROVAL OF A FIRST AMENDMENT BETWEEN THE CITY OF DENTON AND USIC LOCATING SERVICES, LLC, AMENDING THE CONTRACT APPROVED BY CITY COUNCIL ON JULY 20, 2021, IN THE NOT-TO-EXCEED AMOUNT OF \$4,500,000.00; SAID FIRST AMENDMENT TO CONTINUE LOCATING AND MARKING ALL EXISTING AND FUTURE INSTALLED UTILITY LINES FOR DENTON MUNICIPAL ELECTRIC, TECHNOLOGY SERVICES, WATER, AND WASTEWATER DEPARTMENTS; PROVIDING FOR THE EXPENDITURE OF FUNDS THEREFOR; AND PROVIDING AN EFFECTIVE DATE (RFP 7672 – PROVIDING FOR AN ADDITIONAL FIRST AMENDMENT EXPENDITURE AMOUNT NOT-TO-EXCEED \$1,125,000.00, WITH THE TOTAL CONTRACT AMOUNT NOT-TO-EXCEED \$5,625,000.00).

WHEREAS, on July 20, 2021, City Council awarded a contract to USIC Locating Services, LLC in the amount of \$4,500,000.00, for locating and marking all existing and future installed utility lines for Denton Municipal Electric, and the Technology Services, Water, and Wastewater Departments; and

WHEREAS, this procurement was undertaken as part of the City's governmental function; and

WHEREAS, the additional fees under the proposed First Amendment are fair and reasonable and are consistent with, and not higher than, the recommended practices and fees applicable to the Provider's profession, and such fees do not exceed the maximum provided by law; NOW, THEREFORE,

#### THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

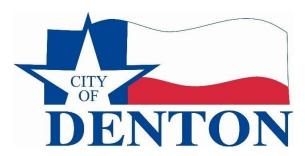

# FIRST AMENDMENT TO CONTRACT BY AND BETWEEN THE CITY OF DENTON, TEXAS AND USIC LOCATING SERVICES, LLC (File 7672)

THIS FIRST AMENDMENT TO CONTRACT 7672 (this "Amendment") by and between the City of Denton, Texas ("City") and **USIC Locating Services, LLC** ("Contractor") to that certain contract executed on July 20, 2021, in the original not-to-exceed amount of \$4,500,000 (the "Agreement"); for services related to the **Utility Line Locating.** 

WHEREAS, the City deems it necessary to further expand the services provided by Contractor to the City pursuant to the terms of the Agreement, and to provide an additional not-to-exceed amount \$1,125,000 with this First Amendment for an aggregate not-to-exceed amount of \$5,625,000; and

WHEREAS, this amendment incorporates any previously executed documents between the parties including but not limited to pricing adjustments.

WHEREAS, the City deems it necessary to further expand the goods/services provided by Contractor to the City; and

WHEREAS, the original not-to-exceed amount may not be increased by more than 25.0% as provided in Texas Local Government Code Sec. 252.048; and

NOW THEREFORE, the City and Contractor (hereafter collectively referred to as the "Parties"), in consideration of their mutual promises and covenants, as well as for other good and valuable considerations, do hereby AGREE to the following First Amendment, which amends the following terms and conditions of the said Agreement, to wit:

1. This Amendment modifies the Agreement amount to provide an additional \$1,125,000 for additional services and materials to be provided in accordance with the terms of the Agreement with a revised aggregate not-to-exceed total of \$5,625,000.

The Parties hereto agree, that except as specifically provided for by this Amendment, that all of the terms, covenants, conditions, agreements, rights, responsibilities, and obligations of the Parties, set forth in the Agreement remain in full force and effect.
