SUBJECT

Consider recommending approval of the 2025 Airport Master Plan Update.

BACKGROUND

Airport master plans are comprehensive, long-range planning documents that guide the future development of an airport. They are essential tools used by airport sponsors, planners, and governing bodies to ensure that the airport can meet future aviation demand in a safe, efficient, and environmentally responsible manner.

The Federal Aviation Administration (FAA) recommends that public-use airports develop and periodically update master plans to reflect changes in aviation activity, community needs, and regulatory requirements. The last master plan update for Denton Enterprise Airport occurred in 2015. A typical master plan includes forecasts of future aviation activity, an assessment of facility needs, alternatives for development, and a financial implementation plan. It also incorporates stakeholder input and aligns with local, regional, and national transportation goals.

The primary objectives of an airport master plan are to:

- Provide a clear roadmap for future airport development.
- Ensure the airport remains safe, efficient, and responsive to demand.
- Support sound financial planning and capital investment.
- Promote compatibility with surrounding land uses and environmental stewardship.
- Facilitate coordination with federal, state, and local agencies.

The master planning process is collaborative and data-driven, involving input from airport users, community stakeholders, and regulatory agencies. The final product serves as a strategic guide for decision-making and capital improvement programming over a 20-year planning horizon.

The 2025 Master Plan Update received 90% grant funding from the FAA of \$709,779.60 with a City match of \$78,864,40.

Process

The process for the master plan was broken into three (3) phases:

- 1. Take an inventory of existing conditions and develop aviation forecasts
- 2. Assess airport demand/capacity and develop facility requirements; analyze development alternatives

3. Develop a recommended development concept (with environmental considerations); develop a concept capital improvement program.

Airport stakeholder engagement is a significant part of the planning process. A Planning Advisory Committee, consisting of Airport and community partners, was convened on four (4) occasions to provide ongoing input into the process. Stakeholder engagement also included regular town hall meetings to update the public on the planning process. A planning website was launched to solicit feedback and provide information and document drafts.

Final Draft

The Airport Advisory Board will be provided a summary of the final Airport Master Plan report. This report will include details in all phases of the plan, the recommended development concept (e.g. how the airport may develop over the next 20 years based on existing data and forecasts) and financial information related to that development.

The master plan serves as a critical tool for positioning Denton Enterprise Airport for future growth and investment. It translates long-term planning into actionable priorities, identifying specific projects that enhance capacity, safety, and operational efficiency. One of the most important outcomes is the updated Airport Layout Plan (ALP), which is submitted to the FAA for review and approval. The ALP, along with supporting documentation such as aviation forecasts and facility requirements, ensures the airport remains eligible for federal funding and provides a clear basis for future grant applications. By aligning development goals with FAA standards, the master plan strengthens the airport's ability to secure resources and implement improvements in a timely, coordinated manner.



ADMINISTRATIVE UPDATE November 2025

2025 HALLO-WING

The 2025 HALLO-WING event was held on October 11, 2025, and marked a shift in format from previous years. This year, the event was hosted entirely by the City's fixed base operator, Sheltair. To manage costs associated with large crowds, attendance was limited to 150 vehicles, with a per-vehicle ticket price of \$25. The event sold out and welcomed an estimated 600 to 700 attendees. In addition to the popular aircraft trick-ortreat stations, a new outdoor movie attraction was introduced. While scaled down in size, the event was a success and offers a more sustainable model for future years.

West Side Agriculture Lease

The Airport recently executed a lease agreement for a parcel of land on its west side to be used for agricultural purposes (i.e. hay baling). The property was previously leased by Webster and Son, LTD and is now under agreement with Rafter B Farms, LLC. The lease is projected to generate \$2,640.00 in annual revenue and will remain in effect for an initial term of one (1) year, with four (4) additional one-year extension options available. This arrangement supports productive interim use of undeveloped airport property while maintaining compatibility with aviation operations.

Closure of a Portion of Skylane

As part of ongoing airfield improvements, Skylane Drive will permanently close between Airport Road and Spartan Drive beginning at 6:00 a.m. on Monday, December 15, 2025. Starting on this date, all airport roads south of Taxilane Hotel must be accessed via John Carrell Road. This closure is necessary to support the extension of Taxilane Hotel and connect it to the airport property east of Skylane Drive. The project is a key step in increasing airfield access to airport property and supporting airport growth.

Staff will be communicating this change via email, the Airport website, and on-site signage. We will encourage all airport users, tenants, and visitors to plan ahead and begin using John Carrell Road to access the southern end of the airport (see map below).
