### **BACKGROUND**

The Denton City Charter was originally adopted in February 1959. Section 14-13 of the Charter states that amendments to the charter may be framed and submitted to the voters subject to requirements of the Texas Local Government Code, Chapter 9, and all other applicable laws. Since its original adoption, the charter was further amended in 1976, 1980, 1999, 2006, 2009, and 2017.

On June 4, 2024, the City Council approved Resolution 24-1158 to create the Charter Review Committee and issue the charges put forward by the Council. Charge J put forward by Council directs the Committee to, "consider and advise the City Council of Denton whether and in what manner to revise the current City Charter provisions of Article XIV, Section 14.04 as to modify the Ethics Ordinance requirements."

### **Background & Scope**

- The Charter Election of 2017 created the Ethics Ordinance requirement.
- Following the election, the City created the Board of Ethics and charged them with creation and any future revisions of the Ethics Ordinance.
- The Ethics Ordinance requirements provisions stipulate the minimum requirements for the Ethics Ordinance.
- The Charter Committee's charge is limited to revising the Charter provision, and not the Ethics Ordinance itself.

### **Current Provision**

### **Section 14.04. Ethics Ordinance Requirement**

The City Council shall adopt an ethics ordinance. The ethics ordinance shall prohibit the use of public office for private gain and shall incorporate the conflict of interest standards that appear in V.T.C.A., Local Government Code, Ch. 171, and all state law as presently exist or may be hereafter amended or adopted. The Council may adopt more stringent standards than those that appear in state law, but the ethics ordinance shall, at a minimum, include the following components:

- 1) Definition of a prohibited improper economic interest and personal gain;
- 2) Definition of recusal and improper participation when a potential conflict of interest is present;
- 3) Avoidance of appearance of a conflict of interest; and
- 4) Administration and enforcement of ethics ordinance, including the power to subpoena witnesses and documents, coupled with strong and meaningful remedies for infractions.

### Committee Charge:

### **Considerations**

- No other cities found to have adopted or considered a similar provision.
- Current City employee benefits extend to legal spouses regardless of gender or identity (documentation required).
- Other areas of City Code where marriage is defined or referenced:
  - Code of Ordinances Article XI. Ethics "relative" defined as a family member related to a city official within the third degree of affinity (marriage) or consanguinity (blood or adoption) in accordance with state law.
  - Code of Ordinances Chapter 17. Property Maintenance Code "family" defined as two or more persons
    occupying a single dwelling unit where all members are related by blood, marriage, adoption, or legal
    guardianship of minors.
  - Denton Development Code Subchapter 9. Definitions "family" defined as one or more persons related by blood, marriage, or legal adoption.

### Committee Charge:

Consider implementing a oneyear residency requirement for individuals serving on a citizen board, committee, or commission appointed by Council.

### **Current Provision(s)**

### Charter Section 14.16. Boards and commissions.

Members of boards and commissions of the City of Denton shall serve at the pleasure of the council. Members of such boards and commissions may be removed by the council only for cause and only after being given notice by the council.

City of Denton Code of Ordinances Article III. Boards, commissions, and committees.

Each member of a board or commission, in addition to qualifications prescribed by federal or state law or ordinance, shall be a resident of the city who is 18 years of age or older.

### **Background & Considerations**

- In 2022, City Council amended the Code of Ordinances to change the requirement from "registered voter" to "resident"
- Historically, there has not been a time-specific residency requirement for service on boards, commissions, or committees appointed by Council.
- Planning & Zoning (P&Z), Zoning Board of Adjustment (ZBA), and Public Utilities Board (PUB) are required by state law and have separate Charter provisions.
  - PUB is required by the Charter to have the same qualifications as Council, which includes a one-year residency.
- Some committees have special requirements for service, but none require a time frame for residency.
- Estimate of current appointment vacancies: 14

Section 14-13 of the Charter states that amendments to the charter may be framed and submitted to the voters subject to requirements of the Texas Local Government Code, Chapter 9, and all other applicable laws. Since its original adoption, the charter was further amended in 1976, 1980, 1999, 2006, 2009, and 2017.

On June 4, 2024, the City Council approved Resolution 24-1158 to create the Charter Review Committee and issue the charges put forward by the Council. Charge K put forward by Council directs the Committee to, "have the discretion to review additional sections of the City Charter not listed in the above charges and consider and advise whether and in what manner to revise the current City Charter."

On September 19, the Charter Review Committee considered additional items to review. A committee member proposed implementing a one-year residency requirement for individuals serving on a citizen board, committee, or commission appointed by Council. The proposal received a majority vote of the committee to receive a report, hold a discussion, and give staff direction on the topic.

Staff will present relevant information, industry best practice recommendations, and other considerations related to implementing a one-year residency requirement for individuals serving on a citizen board, committee, or commission appointed by Council.
