The Public Art Committee (PAC) elects a chairperson and vice-chairperson from its members annually. The Boards, Commissions, and Council Committees Handbook requires:

Election of Officers

Procedures for the election of officers for appointed boards are established to ensure consistency with the City Council's goals and policies in making board appointments. Except where otherwise provided by state law, federal law, City Charter, or City ordinances or resolutions, election of officers for City of Denton council-appointed boards will be as follows:

- The chair and vice-chair will be elected by voting board members.
- Election of officers shall be annually as soon as practicable after the annual appointment process. If, for any reason, the chair or vice-chair vacates their seat, a special election should be held to fill the unexpired term. A temporary chair may be selected by the board pursuant to Roberts Rules of Order.

Today, the PAC is asked to elect those individuals to serve the roles of a Chair and Vice-Chair for two years or until a successor is elected.

BACKGROUND

This item provides information about recent and upcoming arts projects and seeks feedback from the committee on those projects and plans.

CURRENT PROJECTS

Traffic Box Wraps

Parks and Recreation Staff are seeking art for about four (4) traffic boxes downtown to install in the present calendar year and have activated both an internal employee contest seeking and a public call for art as well. Staff solicited artwork from the general public, but the response was rather limited. Staff, in conversation with GDAC, determined that a \$200 honorarium for traffic box art would help Parks and Recreation attract better works of art from professional or semi-professional artists. An RFP is in progress and will be completed and circulated soon and will be promoted with the help of Marketing and Communication.

Previously, staff reached out to the Scary Orchard participants and the general public for an artist call that did not offer an honorarium. Staff received only one or two submissions that seemed fitting for public display. If any of these artworks are used, an honorarium will be paid to the artist. But it is hoped that an ongoing honorarium will help supply the city with high-quality works from working artists. Additionally, expending an honorarium in this way also helps the City support our local arts community with HOT (Hotel Occupancy Tax) funds.

By the time you are reading this the new Call for Artists should be live and shared on City of Denton / Parks Social media assets.

Chairy Orchard 2.0

As a reminder, Parks and Recreation Staff are currently considering an extended, and large-scale, art installation that would serve as a Chairy Orchard 2.0. This project will not replicate the irreplaceable original but instead will seek to provide an expansive series of curated art spaces that are inspired by the Chairy Orchard and its sense of wonder and whimsy. Parks and Recreation Staff are currently imagining placing the Chairy Orchard 2.0 in South Denton at the future sites of the Active Adult Center and the South Branch Library.

Currently, staff are in the process of building a list of prospective artists for the Chairy Orchard whose aesthetic commitments match that of the original Chairy Orchard. The Chairy Orchard will be supported by the public art bond funds connected to the Active Adult Center and new South Branch Library. Design conversations about the Chairy Orchard 2.0 should begin in earnest in FY25-26, as the bond issues for public art for the Active Adult Center and the new South Branch Library occur in FY 26-27 and FY28-29.

Fire Stations #5 and #6

Staff finalized the Call for Artists for each of these fire station public art projects in January and released the calls on the City's ionwave procurement website in that same month. The call for artists was also published on Glasstire, publicartist.org, codaworkx, on City of Denton social media, and shared with GDAC and other local and regional arts partners. The artist call will be open until the end of March.

Fire Station #5 is located near the location of the present fire station at the corner of N. Bonnie Brae Street and W. Windsor Drive, along the western edge of North Lakes Park. Fire Station #6 will be a new fire station location at 2301 Hunter's Creek Road off of Teasley Lane in southern Denton. Funding for both projects is provided by the 2023 Bond program, with each project receiving just over \$250,000.00 in bond-funded support.

Animal Services Center Expansion

Similarly, staff are working to finalize an RFP Call for Artists for the Linda McNatt Animal Shelter expansion project. This RFP, like those for the fire stations, will similarly call for a powerfully iconic work of landmark placemaking related to the joys of animal companionship and pet ownership. The Call for Artists will be placed on all the forums where the Fire Station calls were placed, and staff may reach out directly to additional artists directly to encourage their participation in the Call for Artists. The Animal Services Center Expansion RFP/Call for Artists should post by the end of January and be open until the end of March.

Funds for the Animal Services Expansion were approved under the same public safety proposition in the 2023 Bond Program as the funds paying for Fire Station #5 and Fire Station #6. The public art component of the Animal Services Expansion is supported by \$317,000.00 in bond funds.

Blazier Memorial Play Wall

The Blazier Memorial Play Wall is a concreate sculpture about 5ft tall and 40 feet wide that is located just north of the Senior Center on the Eastern side of Quakertown Park. Recently, parks maintenance staff grew concerned that wall needs repair and may be growing dangerous to play on. This item is considered in detail in its own AIS.

FUTURE PROJECTS

Temporary Art Possibilities

Developing a temporary art program is currently in the planning stages. Properly developing this program might need to wait until a new, overall Public Art Policy for the City of Denton is clarified. Additionally, a new Public Art Policy might also need an overall Public Art Master Plan to help map out the future of Public Art in Denton. Parks and Recreation staff will also have to identify locations for temporary public, and build platforms to host temporary public art.

Updating Public Art Policies and Public Art Planning

Parks and Recreation staff proposed changes to the existing Public Art Policy recently. However, these changes were put on the backburner in anticipation of possible changes to the Public Art Committee and the Parks, Recreation, and Beautification Board. As those changes do not seem to be immediately on the horizon, now may present an opportunity for Parks and Recreation staff, working together with the Public Art Committee to finalize a new public art policy and to articulate a public art plan for the next four to five years.

The Public Art Policy was last revised in 2013 and a Public Art Master Plan was published in 2016.

RECOMMENDATION

None.

ESTIMATED SCHEDULE OF PROJECT

Employee art installation on Traffic Box Wraps should occur shortly after PAC chooses winning submissions in February. Additional traffic box wraps will be installed in FY24-25. Planning for the first slate of Bond-related Public Art projects is currently underway with staff sharing preliminary design consideration documents with Fire and Animal Services staff. Future bond projects include the Active Adult Center and the S. Branch Library. Preliminary design discussions for these projects should begin in 2025 and 2026, respectively.

OPERATIONAL IMPACT

Each project will have an anticipated maintenance need. Staff are currently working on determining an inspection and asset management protocol under the updated Public Art Policy that will allow for inspections of larger artwork on an annual basis, leading to more accurate estimates of maintenance needs on a year-to-year basis.





Call for Artists – Traffic Box Art Wraps

A. Scope of Services

The City of Denton Parks and Recreaton Department is seeking art for installation as vinyl wraps on traffic boxes in Downtown Denton (Original Denton District). Artists' proposals should include designs that work well with the physical space of the traffic boxes and that can be adapted as well to auxiliary boxes that are also sometimes located alongside full-sized traffic boxes. The best designs either feature overall patterns, or designs that have specific "faces" adaptable to the three-dimensionality of the traffic and auxiliary boxes. Artists whose work is chosen for installation and was received under the previous 2024 public call for traffic box art will receive the honorarium offered under this Artists' Call.

B. Project Funding

This project is funded through local hotel occupancy tax (HOT) revenues allocated to the City of Denton Parks and Recreation Department to support local public art endeavors.

C. Project Budget and Honararium

The City of Denton currently has funds budgeted to support a number of traffic boxes within Downtown Denton. The budget includes the cost of printing and installing the art work, as well as the payment of an honorarium to the artist of \$200.00 for any art work that is chosen for installation.

D. Eligibility

This opportunity is open to any artists at least 18 years of age. All artists must meet existing City vendor requirements. Artists whose work is chosen will be asked to fill out relevant City and Federal tax forms. Artists must live within Denton County, with preference given to artists who reside within the City of Denton itself.


E. Initial Traffic Locations

City Staff are seeking to install traffic boxes at the following locations:

- Eagle Dr. at Fort Worth Drive
- Eagle Dr. at Dallas Drive
- Eagle Dr. at Carroll Blvd.
- Fort Worth Dr. at Carroll Blvd.

The City may chose to install additional artworks received during this call on additional traffic boxes. Fore each traffic box installed, they City will pay an honorarium. See map below for current locations.

F. Specifications for the Project

DESIGN GUIDELINES

The following design guidelines should be followed by the artist(s):

- Artwork should directly convey the theme: "Embracing Denton's unique culture, people, and passion."
- All artwork should be original and created by the human artist-applicant. Al-produced art will be summarily rejected.
- Art works can feature major Denton landmarks or Texas theming, but treatment of landmarks should be original and avoid common treatments of Denton imagery – e.g. the façade of the Historic Denton Courthouse.
- Artwork should be appropriate for display in public where it will be seen by individuals
 of all ages.
- Artwork cannot feature acts of violence; drug, alcohol, or tobacco use; or advertising or logos, except for vinyl wraps that have been sponsored through Denton Parks and Recreation.
- Artwork should be designed in such a way that the design works with the threedimensional shapes of traffic boxes and auxiliary boxes.



SPECTRUM OF APPROPRIATE SHADES

To prevent overheating of electronics within the box, most of the box background should be in lighter shades. Representative, acceptable shades are shown in the box below. Certain elements can be darker than these shades, but overall, the design should not feature large areas of dark colors

DESIGN DIMENSIONS

The traffic boxes have general uniformity of design, although some boxes do vary in their shapes slightly. The designs that work the best are those with overall patterns or which feature designs with some wiggle room for centering on the various faces of actual traffic boxes.


Typical Main Box and Side Box Dimensions

Main Box: 54H x 44W x 30D

Side Box: 48H x 16.5W x 16D

Auxiliary Box: 49H x 16W x 16D

For auxiliary boxes, in-house graphics designers generally adapt the design, or an element of the proposed design, such that the auxiliary box and the main box remain a matching and cohesive design.

G. Digital Submission Requirements

- Submission Image Guidelines: For preliminary consideration, artists should submit concept art that is uploaded in JPEG format with at least 1500 pixels on the shortest side.
- You can submit your art for consideration using the following online form: https://tinyurl.com/me5hd3jm
- Artists whose artwork is chosen for installation will have to register as vendors with the City and fill out relevant IRS (W-9) and City documentation (Conflict of Interest Questionnaire).

G. Project Schedule

Artists should have their proposals submitted to the City of Denton for consideration by **February 10, 2025.** Winning artists will be contacted as soon as their art is selected by the City for placement Downtown. Payment of the honorarium will be made following the

installation of the traffic box wrap. Installations will begin in February once final digital files of artworks are received from selected artist.

H. Selection Process

The City of Denton Public Art Committee (PAC), or a subcommittee of PAC and City Staff members, will review the proposals and select the artist whose submission and qualifications demonstrate best the ability to complete the project. The Public Art Committee's recommendation will then be presented to City Council for their consideration and final approval.

Call for Artists – Fire Station #5

A. Scope of Services

The City of Denton Parks and Recreaton Department is seeking proposals for a permanent public art installation to be installed at the site of the new **Fire Station #5** at **2230 W. Windsor Drive, Denton, TX 76207**. Artists' proposals should include designs for an iconic, place-making art project that showcases Denton's commitment to being in the vanguard of municipal public art.

B. 2023 Bond Program and Public Art Impact

The public art project is part of series of bond propositions passed by Denton voters in November of 2023. Each of the vertical construction projects passed by voters included a corresponding public art component that allocated just under 2% of total costs to project-related public art. Previously, the City of Denton had largely funded public art projects through an annual allocation derived from a portion of the City's HOT (Hotel Occupancy Tax) Revenue funds.

Funding allocated to public art in the 2023 Bond Program is of an order of magnitude unprecedent in Denton's public art history. 
C. Project Budget

The City of Denton will entertain proposals that cost between \$100,000 and \$200,000. This allocation must support all costs for designing, creating, and installing the artwork, including but not limited to materials, engineering, research, fabrication, site installation modifications, and artists fees. The City will work with the artist on preparing the site to accept the artwork, and any additional considerations – e.g. for integrated lighting – may be negotiated between the City and the artist as part of the final contract negotiations.

D. Eligibility

This opportunity is open to all practicing artists who are at least 18 years of age. All artist and artist teams selected as finalists must attend all required information sessions and site visits. The artist or team that is selected for the Award must identify a locally based **Project Representative** who lives within a 75-mile radius of the Project Site. The project representative will serve as the main project contact and will have the ability to be on-site for project related meetings within 24 hours of receiving a meeting request.


Fig 1: Fire Station #5 Art Location Plan



E. Project Site




Fig 2: Fire Station #6 Location Site Plan

The artwork will be sited at the location of the new Fire Station #5 at 2230 W. Windsor Drive in Northwest Denton on the parcel of land identified by Property ID: 957877 at the <u>Denton County Cental Appraisal District</u>. Potential locations for art are on the western and eastern sides of the building (See **Fig.1 for Art Location Map, and Fig. 2 for Site Map**).

F. Specifications for the Project

The proposed artwork must be located in close proximity to the vertical construction project supported by the bond funding such that the art work is clearly an element of the overall project. Call for Artists - Fire Station #6

A. Scope of Services

The City of Denton Parks and Recreaton Department is seeking proposals for public art for permanent installation at site of **Fire Station #6** at **2301 Hunter's Creek Road, Denton, TX.** The Proposals provided by artists should include designs for a permanent outdoor art installation, of significant scale and impact, to be located at the site of **Fire Station #6**. Proposals should provide an iconic, place-making art project that showcases Denton's commitment to being in the vanguard in public art.

B. 2023 Bond Program and Public Art Impact

The public art project is part of series of bond propositions passed by Denton voters in November of 2023. Each of the vertical construction projects passed by voters included a corresponding public art component that allocated just under 2% of total costs to project-related public art. Previously, the City of Denton had largely funded public art projects through an annual allocation derived from a portion of the City's HOT (Hotel Occupancy Tax) Revenue funds.

Funding allocated to public art in the 2023 Bond Program is of an order of magnitude unprecedent in Denton's public art history. It is imperative that the present art project, as one of the first bond-supported public art projects, provide a striking addition to Denton's public art inventory commensurable to the level of funding supporting the project.

C. Project Budget

The best location for art with this project is along the eastern edge of the property that has a long frontage on Teasley Lane (See Fig 1).

SUBJECT

Receive a report, hold a discussion, and give staff direction regarding recent repairs to the Betty Jane Blazier Memorial Play Wall at Quakertown Park.

BACKGROUND

The Betty Jane Blazier Memorial Play Wall is a large concrete structure designed for climbing and children's play, located on the eastern edge of the park, between the Civic Center Pool and the Denton Senior Center. The structure is roughly 5 feet in height and 39 feet long. The sculpture was designed by Richard Laing, working with Mount-Miller architects and was installed in the park in 1970. Funding for the wall came from Denton's Unitarian Fellowship who named the sculpture in honor of Betty Jane Blazier, a beloved instructor at the College of Household Arts and Sciences at Texas Woman's University who passed away in 1964, at the young age of 48 years old.

Recently, during a routine Parks Maintenance inspection of the sculpture, staff noted a number of cracks and abrasions on the artwork's surface (see **Exhibit 3- Blazier Play Wall Condition Images**). Park Maintenance staff and concrete experts from Floyd Smith Concrete, Inc. determined that repair of the present surface wear would cost more than \$4,000.00. Given the sculpture's current age of over 50 years, staff are exploring whether repairs make sense, whether the repairs can in fact arrest the overall degradation of the sculpture's aged concrete in a manner consistent with the original construction by the artist, and if it might be better for repairs to be halted on the sculpture with the expectation that a replacement is on the horizon.

Parks Maintenance staff also expressed concerns regarding the safety of the structure, especially given its usage as a play structure. The sculpture is not, currently, included within the City's playground inventory and is not subject to the same safety scrutiny that attends active playgrounds. Playgrounds are required to maintain certain standards regarding overall safety and fall attenuation. The Blazier Memorial Play wall has not been inspected under the same criteria. Parks Maintenance staff would like to discourage climbing on the play wall and are considering posting "do not climb" signage to that effect next to the work.

Any replacement for the current sculpture will have to be incorporated into the evolving, revised Quakertown Park space as it develops out of the recent Design Downtown Denton process.

The sculpture is included as part of the O'Neil Fort historical local designation so any recommendations about the future of the sculpture will also have to be shared and deliberated with the Denton Historical Landmark Commission.

ESTIMATED SCHEDULE OF PROJECT

Park Maintenance staff anticipate that surface repairs to the concrete sculpture could be completed within 1 to 2 months, depending on the weather. Replacement of the sculpture would need to be phased with the redevelopment of the entire park. The phased redevelopment of Quakertown Park will be contingent, as well, on the overall availability of funding. Production time for a large-scale concrete sculpture would itself take around six months to a year, after a final candidate is chosen through the Public Art Committee's artist call process.

RECOMMENDATION

Parks and Recreation Staff are asking the Park Board to discuss, deliberate, and vote in favor of one of the following positions:

- 1. Continue to maintain the Blazier Memorial Play Wall until a more cohesive art and monuments plan is developed for Quakertown Park in line with the Design Downtown Denton initiative.
- 2. Providing minimal maintenance on the Blazier Memorial Play Wall with the understanding that the entire sculpture will be replaced sometime during the next several years, as the overall park space develops in line with the Design Downtown Denton and Quakertown redevelopment plans.
- 3. Remove the sculpture in advance of further degradation. Provide a plan for replacing the artwork that includes a robust public input process and attends to the cultural needs of the Park in line with the Design Downtown Denton Plan and Quakertown redesign.

FISCAL INFORMATION

A funding source for repairs has not yet been identified. The cost of the repairs will be \$4,500.00.



Location



Present Concerns

- Sculpture requires repairs to surface concrete
- Additional, more comprehensive and structural repairs may be necessary
- Sculpture is not assessed or safety in the same way as a playground is, although it
 is often used as a climbing structure. Parks Maintenance staff want to discourage
 climbing
- Sculpture may need intensive repairs such that, given its age, it may make more sense to invest in a replacement.
- How will the sculpture or any possible replacement cohere with the redesigned Quakertown Park as recently laid out in the Design Downtown Denton process.

Historical Designation

The sculpture is included as part of the O'Neil Fort historical local designation so any recommendations about the future of the sculpture will also have to be shared and deliberated with the Denton Historical Landmark Commission.

Options For Consideration

Staff would like to place "Do Not Climb" signage on the sculpture regardless of chosen direction.

- 1. Continue basic maintenance to the Blazier Memorial Play Wall until a more cohesive plan for its long-term restoration or replacement is determined in line with the Quakertown redesign and Design Downtown Denton. Officially assess structure as a play structure
- 2. Freeze maintenance with the understanding that the sculpture will be replaced in the next few years in line with Quakertown redesign plans
- 3. Remove the sculpture in advance of future degradation and to avoid safety concerns. Provide a plan for replacing the work that includes public input
