SUBJECT

Consider adoption of an ordinance of the City of Denton, a Texas home-rule municipal corporation, authorizing the City Manager to utilize a contract through the North Central Texas Council of Governments (NCTCOG) Purchasing Network, Contract No. 2022-035, for roadway workzone data reporting software for the Transportation Services Department; providing the expenditure of funds therefor; and providing an effective date (File 8918 – awarded to Navjoy Consulting Services, Inc., in the three (3) year not-to-exceed amount of \$299,800.00).

STRATEGIC ALIGNMENT

This action supports Key Focus Area: Enhance Infrastructure and Mobility.

INFORMATION/BACKGROUND

The North Central Texas Council of Governments (NCTCOG) issued a request for proposals for workzone data exchange software and selected five (5) vendors in 2024. The City of Denton reviewed different software in 2024 and selected Navjoy as the software vendor to submit the grant to NCTCOG for the Work Zone Data Exchange Program. The City of Denton was awarded the grant in February 2025, and the Regional Transportation Council authorized NCTCOG to enter into those agreements in May 2025. The City Council approved the interlocal cooperation agreement on October 21, 2025, for funding, and the grant requires cities to enter into a separate agreement with software vendors for the procurement of the software.

Following approval, the NCTCOG Workzone Data Exchange Grant will cover 100 percent of the costs of the software, based on the schedule below. The City will pay invoices on a monthly basis and be reimbursed by NCTCOG for those expenses.

PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On July 17, 2018, City Council approved the interlocal agreement with the North Central Texas Council of Governments (NCTCOG) (Ordinance 18-1074).

RECOMMENDATION

Award a contract with Navjoy Consulting Services, Inc., for roadway workzone data reporting software for the Transportation Services Department, in a three (3) year not-to-exceed amount of \$299,800.

ESTIMATED SCHEDULE OF PROJECT

This is a three (3) year contract. This NCTCOG contract expires on November 30, 2027.

FISCAL INFORMATION

These items will be funded from a Workzone Data Exchange Project Account 352001.7879. Requisition #172550 has been entered into the Purchasing software system in the amount of \$299,800. There is no budgeted amount for this item as it is fully reimbursable by grant funding.
