

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF DENTON, A TEXAS HOME-RULE MUNICIPAL CORPORATION, RATIFYING A CONTRACT AND AN EXTENSION THERETO BETWEEN THE CITY OF DENTON AND AKIMEKA, LLC, THROUGH MARCH 31, 2024, TO PROVIDE DATA RELATED TO DENTON MUNICIPAL ELECTRIC'S EV CHARGERS IN CONNECTION WITH A USDOE PROJECT; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, City staff executed a contract with Akimeka, LLC to share data related to Denton Municipal Electric's EV chargers in connection with a USDOE project; and

WHEREAS, the staff having recommended, and the City Manager having recommended to the City Council that an extension to the existing data sharing relationship continue until the project conclusion; and

WHEREAS, on April 28, 2023, Denton Municipal Electric executed an amendment with Akimeka, LLC, to extend the contract term through March 31, 2024; and

WHEREAS, this procurement was undertaken as part of the City's governmental function; and

WHEREAS, the City Council finds that the action taken herein is in the public interest; NOW, THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

SECTION 1. The findings and recitations contained in the preamble of this ordinance are incorporated herein by reference.

SECTION 2. The City Council hereby ratifies the original contract with Akimeka, LLC dated March 10, 2020 attached hereto as well as the contract amendment executed April 28, 2023 attached hereto.

SECTION 3. The City Council delegates the authority to the City Manager, or their designee, to take any actions that may be required or permitted to be performed by the City of Denton under such contract and amendment to the City Manager or their designee.

SECTION 4. This ordinance shall become effective immediately upon its passage and approval.
