A RESOLUTION OF THE CITY OF DENTON APPROVING THE ISSUANCE AND SALE BY LEGACY DENTON PUBLIC FACILITY CORPORATION OF MULTIFAMILY HOUSING REVENUE BONDS (WATERFORD AT SPENCER OAKS) SERIES 2025 TO PROVIDE AFFORDABLE RENTAL HOUSING; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Legacy Denton Public Facility Corporation (the "Issuer"), a nonprofit public facility corporation, created by the Housing Authority of the City of Denton, Texas, has induced the issuance of Multifamily Housing Revenue Bonds (Waterford at Spencer Oaks) Series 2025 (the "Bonds"), to be issued in one or more series of tax-exempt bonds or governmental notes in an aggregate principal amount not to exceed \$49,000,000; and

WHEREAS, the proceeds of the Bonds will be loaned to 2100 Spencer Road (TX) Owner LP, a Texas limited partnership (the "Borrower"), to finance a portion of the costs of rehabilitation of an approximately 208-unit residential rental development to be known as the Waterford at Spencer Oaks Apartments (the "Project"); and

WHEREAS, Section 147(f) of the United States Internal Revenue Code of 1986, as amended (the "Code"), requires the Issuer to hold a public hearing and obtain the approval by the City of Denton before the Bonds can be issued; and

WHEREAS, the City Council is informed that the requisite public hearing was held by the Issuer on July 10, 2025, at 11:00 a.m., as evidenced by the public hearing minutes attached hereto as Exhibit A; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF DENTON HEREBY RESOLVES:

<u>SECTION 1.</u> The findings and recitations contained in the preamble of this Resolution are true and are incorporated herein by reference.

<u>SECTION 2</u>. The City Council gives its approval for the Issuer to issue the Bonds, the proceeds of which will be loaned to the Borrower to finance the costs of rehabilitation of the Project located at 2100 Spencer Rd, Denton, TX 76205.

<u>SECTION 3.</u> The City Manager is authorized and directed to take any action and to execute and deliver any documents that are necessary or advisable to comply with the terms of this Resolution.

<u>SECTION 4.</u> Nothing in this Resolution shall be construed to create any obligation whatsoever of the City with respect to the repayment of the Bonds. The Bonds shall never constitute an indebtedness or pledge of the City within the meaning of any constitutional or statutory provision, and the Bonds shall never be paid in whole or in part out of any funds raised or to be raised by taxation or any other revenues of the City.

<u>SECTION 5.</u> This Resolution is adopted solely for the purposes of approval under

Section 147(f) of the Code and shall not be construed as a representation, warranty, or other understanding of any kind by the City in respect of the Bonds or the Project. In particular, but without limiting the foregoing, this Resolution does not constitute zoning approval, approval of any building permit, or any other approval required by the City in regard to the Project.

<u>SECTION 6</u>. This Resolution shall be effective as of its date of approval and passage by City Council.
