#### Introduction

The purpose of this funding is to provide grants to law enforcement agencies to equip motor vehicles used by peace officers with certain bullet-resistant components.

#### **Project Abstract:**

This project seeks funding to equip certain patrol and special use vehicles of the Denton, TX Police Department with bullet-resistant components to enhance officer safety. Serving a population of approximately 166,000 persons across 98 square miles, our agency's 220 sworn officers face increasing threats from armed confrontations. This initiative will retrofit approximately 79 frontline vehicles with ballistic panels in the front doors, reducing vulnerability, and improving survivability in hostile encounters.

#### **Problem Statement:**

Law enforcement officers across the United States, Texas, and Denton, TX continue to be assaulted year over year; with many of those assaults involving firearms and being centered around traffic stops, pursuits, or vehicle based incidents and operations. Over 97% of our marked fleet of vehicles lacks ballistic protection, increasing the danger to officers from ambush attacks and gunfire through vehicle doors and glass. FBI data shows that 60% of ambush-style attacks on officers happen while they are in or near vehicles. (Sourced from FBI Law Enforcement Officers Killed and Assaulted (LEOKA) Annual Reports)

## **Supporting Data:**

Officer safety is a nationwide issue. Criminals don't respect state borders. Denton has over 20 miles of Interstate I-35 and well over 50 miles of state highways within it's jurisdiction. Between January 2021 and Oct 2025, 76 Denton PD officers were assaulted; this includes all types of weapons, not just firearms. We have had one officer shot and critically wounded (resulting in their medical retirement from the department) in the last 6 years. Recent data for our department is taken from the Texas Department of Public Safety UCR LEOKA portal. That data shows that in 2022 there were 17 assaults against Denton PD officers. In 2023 there were 16, in 2024 there were 15, and YTD for 2025 there have been 16 including an incident this month where a suspect fired multiple rounds at several officers on a shots heard call. Some of those officers were utilizing their marked patrol units as cover and concealment. Those assaults are again all types of weapons, not just firearms, but shows the continuing threat against police officers in our community. According to the National Law Enforcement Officers Memorial Fund report on law enforcement deaths in 2024, 52 officers nationwide were killed by gunfire. Texas, Illinois, and North Carolina led the the nation in the number of officers killed by gunfire with 5 in each state. Texas led the nation (by a wide margin) in the number of officers shot, with 32. Police officer's vehicles are their offices. It is where most officers spend their shifts; responding to calls, completing paperwork, transporting prisoners, interacting with the public, etc Firearms caused more than 92% of all felonious deaths of law enforcement officers in the line of duty from 1987 through 2019, according to FBI statistics. (NIJ Standard 0101.07 Director's Message)

Nationwide in 2024, there were 39 traffic stop incidents where officers were shot, resulting in 49 officers shot with 12 fatalities. There were 80 officers shot in 62 ambush style assaults resulting in 18 officer fatalities. However there were also at least 26 officers known to have been protected by body armor. There is not data tracking how many officers were shot through vehicle doors or glass. (Law Enforcement Officers Shot in the Line of Duty - 2024 Year End Summary).

#### **Project Approach & Activities:**

The project is centered around 4 main objectives: • Procurement: Acquire NIJ-certified level III+ ballistic front door panels for approximately 79 Denton PD front-line vehicles. • Installation: Partner with a NIJ certified vendor for purchase and installation by trained personnel within 9 months of award. • Training: Conduct officer briefings on ballistic protection capabilities and limitations. • Evaluation: Monitor incident reports and officer feedback to assess effectiveness. Procurement would require obtaining quotes, including a HUB vendor search, and then executing a contract between the City of Denton and the selected vendor. The level III+ ballistic protection is all common handgun rounds plus specific rifle rounds (sometimes referred to as special threat protection or LAPD special threat protection). The updated NIJ standard is 0123.00. Many vendors refer to the older NIJ standard 0108.01 which is common handgun rounds and .308 / 7.62 X 51mm caliber rifles. Installation would require taking delivery of the ballistic panels from the selected vendor and then scheduling installation with our city Fleet Services technicians who are certified Emergency Vehicle Technicians. Specific billing practices would be set up to ensure that installation costs were tracked separately from any other maintenance costs and easily reimbursed. Training would consist of squad meeting / roll call training sessions about the ballistic protection, which vehicles have it installed, and the limitations of the ballistic panels. All departmental personnel would be notified which vehicles have been retrofitted with the ballistic panels. Open source videos of level III+ ballistic panels would be shown during the training sessions to demonstrate the capability of the panels. Evaluation would be an on-going process consisting of monitoring incidents and reports across the department about the panels and employee surveys regarding them. While some survey information would be subjective, incidents and reports would be objective. This information could be reported to the Office of the Governor, Public Safety Office if needed or warranted.

## Capacity & Capabilities:

The City of Denton and the Denton Police Department have extensive experience managing state and federal grants, including previous awards for body armor and tactical equipment. The Grant Writer has substantial experience writing and executing TXDOT grants specifically. Our Fleet Services team will oversee installation logistics, while our Grants Management team will ensure compliance and reporting. Our city maintains a robust procurement system and vendor relationships to ensure proper procedures are followed and purchases are completed in a timely manner.

#### **Performance Management:**

Measuring success of this specific project would require officers being shot at while in or near these vehicles; which ultimately we hope never happens. Short of that we can track the following information and report it to the Office of the Governor, Public Safety Office as required / requested: • Number of vehicles retrofitted • Overall cost of the project • Officer satisfaction via post-installation surveys • Reduction in injuries from vehicle-based gunfire incidents • Compliance with installation timelines and budget • Installation and maintenance issues related to the ballistic panels The Executive staff of the city and of the police department would also be kept apprised of the results of the project.

#### **Target Group:**

The vehicles that are planned to be upfitted with ballistica protection consist of our Patrol, Traffic, Crime Reduction Team vehicles that are model year 2022 or newer and our 3 US Marshals Task Force Officers' unmarked vehicles. That threshold of year model was chosen due to expected service life of our units.

#### **Evidence-Based Practices:**

Although the Denton Police Department does not have a history of officers being shot at frequently, it is a risk that is continuously present every day and night. This project aligns with NIJ standards for ballistic protection and follows best practices outlined by the International Association of Chiefs of Police (IACP) for officer safety. The IACP supports vehicle ballistic protection by showcasing vendors that provide this service at their annual conference trade show. The IACP has a history of supporting safety initiatives in law enforcement.
