SUBJECT

Consider a request by Winkelmann & Associates, Inc. on behalf of JBA Denton LLC for a Final Plat of the Home Zone Denton. The 2.407-acre site is generally located on the southeast corner of U.S. 380 and Ector Street in the City of Denton, Denton County, Texas. (FP24-0038a, Home Zone Denton, Cameron Robertson).

BACKGROUND

The purpose of this Final Plat is to establish one lot with right-of-way dedication and required easements for a general retail use over 15,000 square feet. To develop the proposed retail use, a Planned Development (PD22-0006a) was approved on September 27, 2022, which rezoned the property from Mixed-Use Neighborhood (MN) District to PD-MN District.
