### **BACKGROUND**

# **Texas Enterprise Zone Program**

The Texas Enterprise Zone Program is a State of Texas economic development tool to promote job creation and capital investment in economically distressed areas of the state. Successful applicants are eligible to apply for state sales and use tax refunds on qualified expenditures, based on their capital investment and number of jobs created/retained. The possible value a project could receive is determined by multiplying the maximum number of jobs allocated by the maximum potential refund in the level of capital investment category.

<sup>\*</sup>Double and Triple Jumbo Projects may not count retained jobs for benefit. A Double Jumbo and Triple Jumbo Project must create at least 500 jobs.

To apply for the TEZ program, a project must first seek a nomination from a local community. Communities have a limited number of project designations (Denton has 6) and the state has a maximum number of designations that can be awarded per biennium (105). If approved, this would be the first project of the biennium for Denton. Applicants must also receive local incentives to be eligible.

A project can be located either inside or outside of a designated Enterprise Zone. For projects within an Enterprise Zone, the company must commit that 25% of new/retained employees will meet economically disadvantaged criteria, or be residents of an enterprise zone, or are veterans. For projects outside of an Enterprise Zone, the company must commit that 35% of new/retained employees will meet economically disadvantaged criteria, or be residents of an enterprise zone, or are veterans.

Key aspects of the Texas Enterprise Zone (TEZ) Program are:

- The local city or county must nominate the qualified company as an Enterprise Project and must offer one or more forms of local tax incentive to the company.
- Projects may be physically located in or outside of an Enterprise Zone. The location determines the percent of new employees that must meet economically disadvantaged or Enterprise Zone residence requirements.
- The Enterprise Project must be nominated for a designation period of not less than one year and up to five years, non-inclusive of a 90-day window prior to the application deadline. Employment and capital investment commitments must be incurred and met within this timeframe.
- Applications are scored on criteria that reflect the distress of the area, state priority, and local and private effort.

A simplified graphic of the TEZ process is included below.

### Proposed Nomination: United States Cold Storage, LP

United States Cold Storage, LP is an existing Denton business, which provides its clients with refrigerated and frozen food warehousing and transportation with 37 facilities in 13 states. The project serves clients such as Kraft, Butterball, Jardine Foods, Bar S Foods, and many others. The company has four existing facilities in Dallas, Fort Worth, and Arlington. The company, which has been operating for 126 years, started as American Ice Company in 1899, it was renamed in 1920 and became a wholly owned subsidiary of John Swire & Sons in 1982.

US Cold Storage, LP currently maintains a cold storage facility located at 3255 Jim Christal Road in Denton and is a leader in temperature-controlled storage and transportation logistics for many of the country's largest food providers. The company currently employs 148 with an average salary of \$53,053.

### **About the Project**

United States Cold Storage, LP plans on adding on a second phase to its existing refrigerated warehouse facility and estimate that their investment in new building, machinery, and equipment will create approximately \$35 million in new ad valorem value in Denton. The project involves plans to create 172 full-time jobs with a weighted average salary of \$57,583 over the next five years under the Enterprise Zone Program. If designated as an Enterprise Project by the State of Texas, United States Cold Storage commits to hiring thirty-five percent (25%) economically disadvantaged persons, enterprise zone residents or veterans, for its new or replacement personnel for certified jobs, during its Enterprise Project designation. The company may qualify for up to \$800,000 under the program (Enterprise project: 320 new and retained jobs x \$2,500 = \$800,000 maximum potential refund).

The benefits of nominating US Cold Storage to the TEZ program:

- To US Cold Storage:
  - o Company can apply to receive a state sales and use tax refund
- To Denton:
  - o 25% of new jobs created or existing positions that turn over will be filled by people who are either economically disadvantaged, are residents of an enterprise zone within the City's jurisdiction, or are veterans.
  - o This nomination has no fiscal impact to City.

### FISCAL INFORMATION

Nominating US Cold Storage as an Enterprise Project has no fiscal impact to the City.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DENTON NOMINATING UNITED STATES COLD STORAGE, LP, TO THE OFFICE OF THE GOVERNOR ECONOMIC DEVELOPMENT AND TOURISM THROUGH THE ECONOMIC DEVELOPMENT BANK AS AN ENTERPRISE PROJECT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Denton ("City") has previously passed Ordinance No. 2016-213, electing to participate in the Texas Enterprise Zone Program ("Program") authorized by Chapter 2303, Subchapter F of the Texas Enterprise Zone Act, Texas Government Code ("Act"), and the local economic development incentives available in the City are the same on this date as those outlined in Ordinance 2016-213; and

WHEREAS, the City amended Ordinance No. 2016-213 to revise the City's liaison for communications and to clarify the list of possible incentives that the City may offer through Ordinance 18-1366; and

WHEREAS, the local economic development incentives offered under this resolution and available in the City are the same on this date as those outlined in Ordinance 2016-213, as amended by Ordinance 18-1366; and

WHEREAS, the Governor's Office of Economic Development and Tourism ("EDT") through the Economic Development Bank ("EDB") will consider the project proposed by United States Cold Storage, LP ("United States Cold Storage") as an enterprise project pursuant to a nomination and an application made by the City; and

WHEREAS, the City desires to create the proper economic and social environment to induce the investment of private resources in productive business enterprises located in severely distressed areas of the City and to provide employment to residents in such areas and to other economically disadvantaged individuals; and

WHEREAS, pursuant to the Act, United States Cold Storage has applied to the City for designation as an enterprise project; and

WHEREAS, the City finds that United States Cold Storage meets the criteria for designation as an enterprise project as required by the Act based on the following factors:

- 1. United States Cold Storage is a "qualified business" under Section 2303.402 of the Act because it will be engaged in the active conduct of a trade or business at a qualified business site within the governing body's jurisdiction located outside of an enterprise zone and at least twenty-five percent (25.0%) of the business' new employees will be residents of an enterprise zone, economically disadvantaged individuals, or veterans; and
- 2. There has been and will continue to be a high level of cooperation between the public, private, and neighborhood entities in the area; and

3. The designation of United States Cold Storage as an enterprise project will contribute significantly to the achievement of the plans of the City for development and revitalization of the area.

WHEREAS, the City Council finds that United States Cold Storage meets the criteria for tax relief and other incentives adopted by the City and nominates United States Cold Storage for enterprise project status on the grounds that it will be located at the qualified business site, will create a higher level of employment, economic activity and stability; and

WHEREAS, the City Council finds that it is in the best interest of the City to nominate United States Cold Storage as an enterprise project pursuant to the Act; NOW, THEREFORE,

### THE COUNCIL OF THE CITY OF DENTON HEREBY RESOLVES:

SECTION 1. The above recitals are adopted as findings of the City Council.

SECTION 2. The City Council nominates United States Cold Storage, to the EDT, through the EDB, as an enterprise project that shall take effect on the date of designation of the enterprise project by the EDT and terminate five (5) years after the date of designation.

SECTION 3. United States Cold Storage, is a "qualified business", as defined in Section 2303.402 of the Act, and meets the criteria for designation as an enterprise project, as set forth in Section 2303, Subchapter F of the Act.

<u>SECTION 4</u>. This resolution shall become effective immediately upon its passage and approval.

# **Program Objective**

The Texas Enterprise Zone program is an economic development tool for local communities to partner with the State of Texas to encourage job creation and capital investment in economically distressed areas of the state.

# **Participation**

For a business to receive state tax incentives under the Texas Enterprise Zone Program, the local community must nominate it for enterprise project designation. Each local community has a limited number of projects allocated and the state has a maximum number of 105 that can be awarded per biennium. Applications are accepted quarterly with the deadlines on the first working day of March, June, September, and December. Applications received after 5:00 p.m. for each quarterly application deadline date will not be considered for that current round.

# **Participation Requirements**

- Enterprise project designation is up to a five year period, in addition to a 90-day window prior to the quarterly deadline application/designation date as outlined above. Employment and capital investment commitments must be incurred and met within the 90-day window through the designation expiration date.
- Projects may be physically located inside or outside of an Enterprise Zone.
- If located within a zone, the company commits that 25% of their new employees will meet economically disadvantaged, enterprise zone residency, or veteran requirements.
- If located outside of a zone, the company commits that 35% of their new employees will meet economically disadvantaged, enterprise zone residency, or veteran requirements.
- Jobs must provide employment of at least 1,820 hours during a 12-month period.
- Jobs must exist through the end of the designation period, or at least three years after the date on which a state benefit is received, whichever is later.

# **Benefits to participation**

Designated projects are eligible to apply for state sales and use tax refund on taxable items. The level and amount of refund is related to the capital investment and jobs created and/or retained at the qualified business site.

Double and Triple Jumbo Projects may not have retained jobs for benefit. A triple jumbo enterprise project must create at least 500 jobs.

Capital investment is money paid to purchase capital assets or fixed assets including but not limited to land, buildings, labor used to construct or renovate a capital asset, furniture, manufacturing machinery, computers and software, or other machinery and equipment. Property that is leased under a capitalized lease is considered a qualified capital investment but property that is leased under an operating lease is not considered a qualified capital investment.

**NOTE**: if using a contractor to construct the facility, a "separated contract" (a contract in which the agreed contract price is divided into separately states prices for materials and labor) must be executed. If a "lump sum" contract is executed, a claim for refund of taxes invoiced to, and paid by a third party, will not qualify for a refund under this Program. Please call the Comptroller of Public Accounts' Office at 1-800-531-5441 ext. 51083 if you have any questions regarding this issue.

Local communities may offer benefits to participants under the enterprise zone program as well. These may include tax abatement, tax increment financing, one-stop permitting and others.

# **Enterprise Zone**

An enterprise zone is a census tract block group that has 20% or more poverty rate based upon the most recent decennial census federal poverty level information, a distressed county, a federally designated zone or renewal community.

# <u>Fee</u>

There is a non-refundable application fee for consideration of an enterprise project designation. Enterprise projects will be assessed 3% on the amount of any refund benefit received under the state enterprise zone program.

# TEXAS ENTERPRISE ZONE (TEZ) PROGRAM OVERVIEW

- TEZ is a State economic development tool to promote job creation and capital investment in economically distressed areas.
  - The program requires a partnership with local communities through the local nomination/designation process.
- Successful applicants are eligible to apply for state sales and use tax refunds on qualified expenditures.
- The program provides reimbursements according to the level of capital investment and number of jobs created/ retained for economically disadvantaged individuals or veterans.
  - Enterprise Projects may be located either within or outside of a designated Enterprise Zone, but project criteria are variable based on location.



- Denton held a public hearing and adopted Ordinance 18-1366 in 2018, which confirmed Denton's participation in the TEZ program and allows Denton to make nominations by resolution.

# TEXAS ENTERPRISE ZONE PROGRAM CRITERIA

- Project designations are good for 5 years.
- Jobs must work 1,820 hours minimum per year.

- State application deadlines are the first working day of March, June, September, and December.

# PROPOSED NOMINEE: UNITED STATES COLD STORAGE, LP

- United States Cold Storage, LP (USCS) has submitted a request to the City for consideration of nomination to TEZ as an Enterprise Project.
- USCS will be investing approximately \$35 million at the Denton USCS facility.
  - Investment in a 100,000 square foot expansion
  - Machinery, equipment and tooling to support capacity

# PROJECT ELIGIBILITY

- Current facility is located within an Enterprise Zone.
  - USCS is proposing to invest \$35 million in machinery and equipment and an office and facility renovation to expand plant capacity.
- Project is an Enterprise Project:
  - Investment of \$5M to \$149.99M
  - Max Jobs Allocated: 500 (\$2,500/job)
  - Max Potential Refund: \$1,250,000
  - USCS estimated refund: \$800,000
- City must nominate project





# BENEFITS

# ■ To USCS:

A state sales and use tax refund of up to \$800,000 (320 full-time jobs X \$2,500 per job)

# To Denton:

- 25% of new jobs created or existing positions that turn over will be filled by people who are either economically disadvantaged, are residents of an enterprise zone within the City's jurisdiction, or are veterans.
- Nominating USCS enables Denton to assist the company in receiving state tax refunds.
- Nominating USCS to the program has no fiscal impact to the City of Denton.

- EDPB recommend that City Council approve a Resolution nominating United States Cold Storage as an Enterprise Project.





Customer Service conducted independent evaluations of utility billing and collections processes in 2008, then again in 2018. During review of the commercial deposit requirements, it was determined that an updated review was in order. The FY24/25 budget included council approved funding to review billing & collections processes to ensure operational efficiency and program alignment with utility sector best practices.

Departmental revenue collection performance was reviewed against industry benchmarks. Additionally, three City policies were evaluated and recommendations for improvement were provided. These included commercial deposits, payment agreements, and leak adjustments.

### Leak Adjustment Policy Review

#### Current Policy/Process

- Low customer eligibility.
- · Language excludes renters.
- Policy not aligned with benchmarks from other cities in Texas:
  - Process is hard-coded in Ordinance
  - Permit requirement
  - Short filing time
  - Restrictive policy in comparison

#### Recommended Changes

- Proposed redlines to ordinance are appropriate and will provide needed flexibility to enhance and change Leak Adjustment policy and process going forward without requiring changes to ordinance.
- Eligibility should continue be determined systematically and consistently.
- Discretion to handle individual situational exceptions without City Council approval.
- Self-service application process should be intuitive and offer payment plan options to eligible customers.
- Once Water AMI is available, it will shorten time to identify leaks and alert customers sooner to reduce amounts adjusted.
- Water AMI should be used to verify leak resolution.

### Commercial Deposit Policy Review

#### **Current Policy/Process**

- Denton's 2x average bill deposit requirement is consistent with peers
- Application of deposit interest is consistent with peers.
- Current Ordinance requires manual screening on all deposit refunds.
- Denton's policy to retain deposits for the life of the account is not aligned with benchmarks from other cities in Texas.
  - Most return deposits with 1 to 2 years, with good payment history.

#### Recommended Changes

- Return commercial deposits, with deposit interest, after 2 years total service and at least 12 consecutive months of excellent payment history:
  - Account is current
  - "A" credit rating
  - No disconnections for nonpayment
  - No meter tampering

### Payment Arrangement Policy Review

#### **Current Policy/Process**

- 5-day extensions are available to customers, but employees must manually calculate the due date of the extension (5 days past interruption date) which is time consuming and prone to mistakes.
- Multi-month arrangements (up to 3 months) with 50% of outstanding balance are available, one every six months.
- Only one extension or multi-month arrangement is allowed in six months.
- Ordinance states that payment arrangement guidelines will be established by the City Council and on file in the City Secretary's office.

#### Recommended Changes

- Match due date of payment extension to next bill due date.
- Payment arrangement can be made for up to 3 months with 50% down.
- Do not limit the number of allowed payment arrangements if arrangements are not broken.
- However, if broken twice in 12 months, the customer must wait 12 months before entering another payment arrangement.
- Ordinance should be updated to require payment extension and arrangement guidelines to be approved by the City Manager and on file with the City Secretary. City Council should be notified of any changes prior to implementation.
- Discretion to handle individual situational exceptions without City Council approval.


