SUBJECT

Consider approval of a resolution of the City Council of the City of Denton, Texas, setting a process for the amendment and adoption of updated water and wastewater land use assumptions and capital improvements plans, and the imposition of updated water and wastewater impact fees; directing staff to provide notice of the public hearing as required by law; and providing an effective date.

STRATEGIC ALIGNMENT

This action supports Key Focus Area: Support Healthy and Safe Communities.

INFORMATION/BACKGROUND

The City of Denton is currently updating the Water and Wastewater Impact Fees in accordance with Chapter 395 of the Texas Local Government Code (TLGC). Impact fees are designed to recover the costs of expanding water and wastewater system capacity to accommodate new growth that places additional demands on the system.

The City first adopted impact fees for Water and Wastewater Utilities in September 1998. Per state law, these fees must be updated every five years. The last update occurred in 2018, and the current update process began in August 2022.

In July 2024, City Council provided direction regarding the study methodology and provided a preliminary overview of the fee calculations.
