AN ORDINANCE OF THE CITY OF DENTON, A TEXAS HOME-RULE MUNICIPAL CORPORATION, AUTHORIZING THE APPROVAL OF A SECOND AMENDMENT TO A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF DENTON AND HR GREEN, INC., AMENDING THE CONTRACT APPROVED BY THE CITY COUNCIL ON SEPTEMBER 1, 2020, IN THE NOT-TO-EXCEED AMOUNT OF \$4,973,027.00; AMENDED BY AMENDMENT 1 APPROVED BY CITY COUNCIL; SAID SECOND AMENDMENT TO PROVIDE ADDITIONAL REVIEW OF DEVELOPMENT CONSTRUCTION PROJECTS FOR THE CITY OF DENTON AND THE DEVELOPMENT SERVICES DEPARTMENT; PROVIDING FOR THE EXPENDITURE OF FUNDS THEREFOR; AND PROVIDING AN EFFECTIVE DATE (RFQ 7192 – PROVIDING FOR AN ADDITIONAL SECOND AMENDMENT EXPENDITURE AMOUNT NOT-TO-EXCEED \$800,000.00, WITH THE TOTAL CONTRACT AMOUNT NOT-TO-EXCEED \$7,573,027.00).

WHEREAS, on September 1, 2020, City Council awarded a contract to HR Green, Inc., in the amount of \$4,973,027.00, for the review of development construction projects for the City of Denton and the Development Services Department; and

WHEREAS, on December 13, 2022, City Council awarded a First Amendment to HR Green, Inc., in the amount of \$1,800,000.00, to continue to provide additional review of development construction projects for the City of Denton and the Development Services Department; and

WHEREAS, this procurement was undertaken as part of the City's governmental function; and

WHEREAS, the additional fees under the proposed Second Amendment are fair and reasonable and are consistent with, and not higher than, the recommended practices and fees applicable to the Provider's profession, and such fees do not exceed the maximum provided by law; NOW, THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

SECOND AMENDMENT TO CONTRACT BY AND BETWEEN THE CITY OF DENTON, TEXAS AND HR GREEN, INC. PSA 7192

THIS SECOND AMENDMENT TO CONTRACT 7192 ("Amendment") by and between the City of Denton, Texas ("City") and HR Green Inc. ("Engineer"); to that certain contract executed on September 1, 2020, in the original not-to-exceed amount of \$4,973,027 (the "Original Agreement"); amended on December 13, 2022 in the additional amount of \$1,800,000 aggregating a not-to-exceed amount of \$6,773,027 (the "First Amendment"); (collectively, the Original Agreement, the First Amendment, are the "Agreement") for services related to provide additional review of development construction projects for the City of Denton.

WHEREAS, the City deems it necessary to further expand the services provided by Engineer to the City pursuant to the terms of the Agreement, and to provide an additional not-to-exceed amount \$800,000 with this Amendment for an aggregate not-to-exceed amount of \$7,573,027; and

FURTHERMORE, the City deems it necessary to further expand the goods/services provided by Engineer to the City;

NOW THEREFORE, the City and Engineer (hereafter collectively referred to as the "Parties"), in consideration of their mutual promises and covenants, as well as for other good and valuable considerations, do hereby AGREE to the following Amendment, which amends the following terms and conditions of the said Agreement, to wit:

1. This Amendment modifies the Agreement amount to provide an additional \$800,000 for additional services and materials to be provided in accordance with the terms of the Agreement with a revised aggregate not-to-exceed total of \$7,573,027.

The Parties hereto agree, that except as specifically provided for by this Amendment, that all of the terms, covenants, conditions, agreements, rights, responsibilities, and obligations of the Parties, set forth in the Agreement remain in full force and effect.
