SUBJECT

Consider adoption of an ordinance of the City of Denton determining the public use, need, and necessity for the acquisition of approximately 10.416-acres of land, and a 1.283-acres temporary construction easement located east of Hinkle Drive, north of West University Drive, situated in the Robert Beaumont Survey, abstract No. 31, all in the city and county of Denton, Texas, and more particularly described in the attached exhibit(s) "A" (collectively, the "Property Interest(s)"); authorizing the City Manager and City Attorney, to acquire the Property Interests by agreement if possible, including making all offers required by law; authorizing the use of the power of eminent domain proceedings if necessary; authorizing the expenditure of funding; making findings; providing a savings clause; and providing an effective date.

BACKGROUND

The City of Denton 2023 Bond Program approved the Neighborhood 5B & Oakland Drainage project. The scope of the project includes the design and reconstruction of aging street infrastructure and improvements to drainage and flood control on Oakland Street near the Texas Woman's University campus. The bond program provided funding to acquire critical Property Interests necessary for installing a regional detention pond to offset any downstream impacts from the future improvements, and to reduce the floodplain in the area.

The proposed 10.416-acres of land, and a 1.283-acres temporary construction easement have a combined appraised value of \$1,062,328.

City consultants estimate that this project will remove approximately 34 acres from the floodplain further downstream.

Specialty Land Services has been contracted to provide acquisition services in support of the project.

If a Council member determines that he or she has a conflict of interest pursuant to the Ethics Ordinance, he or she may contact the City Attorney's Office to have a Recusal Form prepared prior to consideration of this agenda item.
