### **SUBJECT**

Consider adoption of an ordinance of the City of Denton, a Texas home-rule municipal corporation, authorizing the City Manager to execute an Interlocal Cooperative Purchasing Agreement with the North Central Texas Council of Governments (NCTCOG), under Section 791.001 of the State of Texas Government Code, to authorize the City of Denton to purchase new Digital Orthophotography Spatial Data from the NCTCOG Geographic Information System for the Technology Services Department, providing for the expenditure of funds therefor; and providing an effective date (File 8676 – awarded to North Central Texas Council of Governments, in a five (5) year not-to-exceed amount of \$650,000.00).

# **STRATEGIC ALIGNMENT**

#### INFORMATION/BACKGROUND

This agreement will enable the City of Denton to obtain the North Central Texas Council of Governments (NCTCOG) up-to-date spatial data for the Geographic Information Systems (GIS) user departments. The data provided is used in a variety of projects including engineering, utility location, urban planning, land use, impervious surface calculations, and GIS applications. Obtaining current spatial data is essential to continue to provide a superior level of service to all user departments and citizens.

Award a contract with North Central Texas Council of Governments, for the purchase of new Digital Spatial Data to purchase new Digital Orthophotography Spatial Data from the NCTCOG Geographic Information System for the Technology Services Department, in a five (5) year not-to-exceed amount of \$650,000.
