WHEREAS, Section 2-83(c)(1)(b), provides "in the event an absence does not meet any of the above noted criteria for an excused absence, the member may submit a request to have the absence excused to the City Secretary's Office in writing no later than ten business days after the date the absence occurred, after which the City Secretary will then place an item on the next available city council agenda for their consideration, in accordance with the Texas Open Meetings Act."; and

WHEREAS, Public Utilities Board Member Susan Parker (Member) was absent from the October 14, 2024, and the October 28, 2024, meetings with the purpose of the absences not meeting the criteria for excused absences; and

WHEREAS, the Member has requested City Council excuse the absences from the October 14 and the October 28, 2024, meetings, for the purpose as stated in Exhibit A; and,

WHEREAS, the City Secretary formally presents the Member's request for excused absences to the City Council; NOW THEREFORE;

THE COUNCIL OF THE CITY OF DENTON HEREBY RESOLVES:

<u>SECTION 1</u>. The reason for Member Susan Parker's absence from the October 14 and the October 28, 2024, Public Utilities Board meetings is sufficient to provide the absences be excused.
