BACKGROUND

The Denton City Charter was originally adopted in February 1959. Section 14-13 of the Charter states that amendments to the charter may be framed and submitted to the voters subject to requirements of the Texas Local Government Code, Chapter 9, and all other applicable laws. Since its original adoption, the charter was further amended in 1976, 1980, 1999, 2006, 2009, and 2017.

On June 4, 2024, the City Council approved Resolution 24-1158 to create the Charter Review Committee and issue the charges put forward by the Council. Charge G put forward by Council directs the Committee to, "consider and advise the City Council of Denton whether and in what manner as to modify the Mayor and Council stipend."

During the 2017 Charter Election, voters approved the adoption of a Mayor and Council stipend for the first time in City history. Previously, Council Members were reimbursed for expenses accrued in their official roles but were otherwise not compensated. The Denton City Charter currently allows for a stipend of \$1,000 per month for the Mayor and \$750 per month for Council Members.

Staff will present relevant information, industry best practice recommendations, and other considerations related to modifying the Mayor and Council stipend.

Charge E:

Increase the two-year Council term to a three or four-year term.

Current Provision

Section 2.01. Number, selection and term

- (c) (1) Each member of the council including the mayor shall hold a place on the city council, and shall be elected to such place for a two-year term. No member of the council or the mayor, who has been elected to three (3) consecutive full terms in a place, shall be eligible to file for election for that same place, whether elected before or after the effective date of this provision, without having first been off the council for at least one annual council election cycle. Nothing herein shall be deemed to prohibit the council members or the mayor from being elected to other places on the council or as mayor, so long as otherwise eligible, except that no council member or the mayor shall be elected to or serve for more than twelve (12) consecutive years.
 - (2) A person who has become ineligible to serve pursuant to Section 2.01(c)(1) shall not be eligible to be elected to a place on the council or as mayor without having first been off the council for at least one annual council election cycle, after which such person shall regain eligibility for office, if otherwise eligible under this Charter.

Current Provision Breakdown

- Two-year term
- Term limit of three consecutive terms in a place
- Nothing prevents a Council Member from seeking election to another place, except if they have served twelve consecutive terms
- A Council Member who becomes ineligible to run under these provisions can restore eligibility by being off Council for one term

Considerations

- **Council History:** 2-year terms since inception
- State Law:
 - **Texas Local Government Code Section 22.035.** The Mayor and Council are elected for a term of two years unless a longer term is established under Article XI, Section 11, of the Texas Constitution.
 - **Texas Constitution Article XI, Section 11.** A Home Rule City may provide by charter or charter amendment, for a longer term of office than two (2) years for its officers, either elective or appointive, or both, but not to exceed four (4) years.

Considerations

Best Practice Recommendations:

- National Civic League Model Charter:
 - Recommends 4-year staggered terms
- Texas Municipal League's Texas General Home Rule Charter (2010):
 - Majority of Texas cities call for staggered two-year terms (recent movement to three or four)

Charge G:

Modify the Mayor and Council stipend

Current Provision

Section 2.02. Qualifications

(c) City Councilmember Stipend. Each member of the City Council shall receive compensation in the form of a monthly stipend as set forth in this section. The initial monthly stipend shall be seven hundred fifty dollars (\$750.00) for each member of the City Council elected from a district or at large position, and one thousand dollars (\$1,000.00) for the Mayor elected at large. These initial amounts shall become effective on ratification of this charter provision.

City Council may, by a separate ordinance, approve an adjustment in the stipend no more frequently than once per fiscal year, but no increase in such compensation shall take effect until commencement of the terms of the Mayor and/or Council Members elected at the next regular election. Any increase in the amount of the stipend shall not exceed three (3) percent of the then-current stipend amount unless approved by a two-thirds (3) vote of the Council. The stipend shall be reported in the annual city budget as a separate line item.

Current Provision Breakdown

- Mayor stipend: \$1,000 per month
- Council stipend: \$750 per month
- Council, by ordinance, may approve an adjustment in the stipend no more than once per fiscal year.
 - No increase will take effect until the next regular term cycle.
 - Any increase should not exceed 3 percent of the then-current stipend amount unless approved by a two-thirds $(\frac{2}{3})$ vote of the Council.
 - The stipend shall be reported in the annual city budget as a separate line item.

Considerations

- History: The Mayor and Council stipend was established through the 2017 Charter
 Amendment Election. Previously, Council received reasonable reimbursement for related expenses, but was not otherwise compensated.
- State Law: Local Government Code Section 141.004, authorizes councils to establish a salary for themselves by ordinance

Considerations

Best Practice Recommendations:

- National Civic League Model Charter:
 - The City should reimburse Council Members for expenses incurred in performing their duties.
 - Council should determine salary by ordinance, allowing for more flexibility and annual adjustments.
 - The Mayor should receive an amount higher than the Council Members, as the Mayor has additional responsibilities (intergovernmental, ceremonial, city-related promotional).

- Monthly rate
- Annual salary rate
- Rate based on Annual Median Income (AMI), etc.

Charge H:

Current Provision

Sec. 4.12. Recall petition, committee of petitioners.

Recall petition papers shall contain the name of the councilman (or names of the councilmen) whose removal is sought, and a **clear and concise statement of the grounds for his (or their) removal.** There shall appear at the head of each petition the names and addresses of five electors, who, as a committee of the petitioners shall be regarded as responsible for the circulation and filing of the petition. Each signer of any petition paper shall sign his name in ink or indelible pencil and give after his name his place of residence by street and number, or other description sufficient to identify the place, and the date his signature was affixed. No signature to such petition shall remain effective or be counted which was placed thereon more than forty-five (45) days prior to the filing of such petition with the city secretary. The signatures to a recall petition need not all be appended to one paper, but to each separate petition there shall be attached an affidavit of the circulator thereof that he, and he only, personally circulated the foregoing paper, that it bears a stated number of signatures, that all signatures were appended thereto in his presence and that he believes them to be the genuine signatures of the persons whose names they purport to be.

Current Provision Breakdown

- Clear and concise statement of the grounds for removal
- Names and addresses of five electors, responsible for circulating and filing the petition
- Each signer will include their name, residence, and the date signed
 - Signed in pen or indelible pencil
 - Signatures over 45 days old will not be counted
- Signatures do not have to be appended to the same paper, but each paper must include an affidavit of the circulator

Considerations

- National Civic League's Model City Charter
 - Petitions should include a statement, not to exceed 200 words, of the reasons for the recall.
 - Grounds for recall should relate to and affect the administration of the official's office and be of a substantial nature directly affecting the rights and interests of the public.
- 2023 University of Houston Study*
 - 36% of Texas city charters include a justification of the grounds for recall
 - Most list "incompetency, misconduct, or malfeasance in office" as the justification.
 - A handful of cities require a hearing before the city council to discuss the allegations before submitting to voters.
- Legal Considerations: Modifying this language will require legal review and analysis.

BACKGROUND

The Denton City Charter was originally adopted in February 1959. Section 14-13 of the Charter states that amendments to the charter may be framed and submitted to the voters subject to requirements of the Texas Local Government Code, Chapter 9, and all other applicable laws. Since its original adoption, the charter was further amended in 1976, 1980, 1999, 2006, 2009, and 2017.

On June 4, 2024, the City Council approved Resolution 24-1158 to create the Charter Review Committee and issue the charges put forward by the Council. Charge K put forward by Council directs the Committee to, "have the discretion to review additional sections of the City Charter not listed on the above charges and consider and advise the City Council of Denton whether and in what manner to revise the current City Charter."

Committee members should submit additional sections of the Charter they wish to review to staff prior to the September 5 Meeting. Each item submitted will be discussed by the Committee and any items receiving approval by a majority of the Committee (8 members) will be reviewed in more detail at a later date.
