SUBJECT

Consider adoption of an ordinance of the City of Denton prohibiting parking on the west side of Evers Parkway between W Windsor Drive and Gardenview Street, and on north and south side of Gardenview between Brook Street and Evers Parkway from 7:00 AM to 8:00 AM and 2:30 PM to 3:30 PM on school days; providing a repealer clause; providing a savings clause; providing for a penalty not to exceed \$200 for violations of this ordinance; providing that violations of this ordinance shall be governed by Chapter 18 of the Code of Ordinances of the City of Denton; and providing for an effective date.

BACKGROUND

Staff received a request from the Principal of Evers Park Elementary School to consider prohibiting parking along the west side of Evers Parkway between W Windsor Drive and Gardenview Street, and on the north and south sides of Gardenview between Brook Street and Evers Parkway during student drop-off and pick-up times, 7:00 AM to 8:00 AM and 2:30 PM to 3:30 PM. After auditing the location and observing current parking situations, staff determined that on-street parking in this area poses safety concerns for motorists, cyclists, and pedestrians, as well as disturbance for neighbors.

RECOMMENDATION

Staff recommend adoption of the ordinance restricting parking along the west side of Evers Parkway between W Windsor Drive and Gardenview Street, and on the north and south sides of Gardenview between Brook Street and Evers Parkway from 7:00 AM to 8:00 AM and 2:30 PM to 3:30 PM Monday to Friday (School days only).

PUBLIC OUTREACH

Staff conducted a virtual meeting Via Zoom on June 24, 2025, to receive community feedback. During the meeting, a community member expressed frustration about having to move their cars during restricted hours. Other participant emphasized their expectation of having parking rights on the street.

ESTIMATED SCHEDULE OF PROJECT

No Parking signs will be installed 30 days after the City Council approves the ordinance. Additionally, the Denton Police Department will begin enforcing the no-parking rules on the designated locations 30 days after the installation of the signs.

FISCAL INFORMATION

Materials for this project will be funded through the Transportation Services via the Traffic Operations general operating budget.
