

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF DENTON AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF DENTON, TEXAS, AND DENTON COUNTY, TEXAS, FOR THE HOLDING AND DISPOSITIONING OF ANIMALS AND THE COLLECTION OF FEES PURSUANT TO THE PROVISIONS OF SAID AGREEMENT; AUTHORIZING THE CITY MANAGER TO PERFORM ALL OBLIGATIONS OF THE CITY UNDER THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, CITY and COUNTY are both local governments with the authority to enter into an agreement pursuant to Chapter 791 of the Texas Government Code; and

WHEREAS, CITY has in its employ trained personnel whose duties are related to the impoundment and dispositioning of animals; and

WHEREAS, CITY is engaged in the services of holding and dispositioning of animals for the benefit of citizens of Denton; and

WHEREAS, CITY is the owner of certain facilities and equipment designed for the holding and dispositioning of animals; and

WHEREAS, the COUNTY desires to access, utilize, and obtain as rendered, as more fully hereafter described, the services, facilities, and equipment of the CITY for the benefit of the residents of Denton County, Texas; and

WHEREAS, COUNTY will make payment to the CITY for services rendered from the County's current revenues and CITY agrees that the payments made by COUNTY in accordance with the agreement will fairly compensate it for the services provided; NOW THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

SECTION 1. The findings and recitations contained in the preamble of this ordinance are incorporated as if fully set forth herein.

SECTION 2. The City Manager or their designee is hereby authorized to execute the Agreement between the CITY and COUNTY for the holding and dispositioning of animals and the collection of fees that is attached hereto and incorporated herein on behalf of the City.

SECTION 3. The City Manager or their designee is further authorized to carry out all duties and obligations to be performed by the City under the Agreement, including, but not limited to, the collection of fees.

SECTION 4. This ordinance shall become effective immediately upon its passage and approval.
