SUBJECT

Consider appointing a nominating committee to recommend appointees to serve on the Economic Development Partnership Board.

BACKGROUND

Per the ordinance establishing the Economic Development Partnership Board (EDPB), the City Council must appoint a three-member Nominating Committee each year. This committee includes:

- Two (2) City Council Members
- One (1) Denton Chamber of Commerce representative

For Council's consideration, two Council Members must be selected to serve on the Nominating Committee. The Denton Chamber of Commerce has selected Marty Rivers as its representative.

The Nominating Committee Scope:

- Soliciting nominations
- Contacting nominees to explain responsibilities and confirm interest
- Gathering recommendations from:
 - Chamber Board of Directors
 - President of UNT
 - President/Chancellor of TWU
 - Denton Black Chamber of Commerce Board
 - Denton Hispanic Chamber of Commerce Board
- Considering diversity, qualifications, and alignment with Board functions
- Presenting a slate of nominees to City Council for approval
