REGISTRATION GUIDELINES FOR ADDRESSING THE CITY COUNCIL

Individuals may speak during a Council meeting under one of the following categories:

Comments on Agenda Items:

Public comments can be given for any item considered by the Council, EXCEPT work session reports or closed meetings. Individuals are only able to comment one time per agenda item and cannot use more than one method to comment on a single agenda item. Public comments are limited to three (3) minutes per citizen.

Individuals may participate by using one of the following methods:

1. In Person for Regular or Consent Agenda Items:

To provide in-person comments on consent agenda items, individuals must be present at the Work Session portion of the meeting. To provide in-person comments on individual consideration items, individuals must be present at the Regular or Special Session portion of the meeting. In both instances, individuals must also submit a speaker card (available at the meeting location) to the City Secretary prior to the item being called.

2. eComment:

The agenda is posted online at www.cityofdenton.com/publicmeetings. Once the agenda is posted, a link to make virtual comments using the eComment module will be made available next to the meeting listing on the Upcoming Events Calendar. Using eComment, Individuals may indicate support or opposition and submit a brief comment about a specific agenda item. eComments may be submitted up until the start of the meeting at which time the ability to make an eComment will be closed. eComments will be sent directly to members of the City Council immediately upon submission and recorded by the City Secretary into the Minutes of the Meeting.

After determining that a quorum is present, the City Council of the City of Denton, Texas will convene in a Special Called meeting on Tuesday, June 17, 2025 at 12:00 p.m. in the Council Chambers at 215 E. McKinney Street, Denton, Texas at which the following will be considered:

BACKGROUND

Adoption of this ordinance will formally canvass the election returns of the runoff election for a council member in District 3 held on June 7, 2025.

The unofficial results are attached as Exhibit A to the ordinance. These results show candidate Suzi Rumohr received 65.57% of the votes cast.

Monday, June 16, 2025, is the last day for the Early Voting Ballot Board to convene and qualify/count provisional ballots, overseas ballots, as well as mail in ballots that are timely postmarked. While minor revisions could modify the unofficial results reported, the outcome of the election is not anticipated to change. A revised exhibit will be provided once the official results are received from Denton County Elections.

AN ORDINANCE OF THE CITY OF DENTON CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE MUNICIPAL RUNOFF ELECTION HELD ON SATURDAY, JUNE 7, 2025; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council finds and declares the June 7, 2025 municipal runoff election was duly ordered for the purpose of electing a Council Member to District 3; proper notice of said election was duly given and election officials appointed; said election was duly held and the returns of the election officials have been delivered to the Council, all in accordance with the laws of the State of Texas and the Charter and ordinances of the City of Denton.

WHEREAS, the official returns of the municipal runoff election have been opened, examined and canvassed; NOW THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

Article II, Section 2.03, of the Denton City Charter states, in part "...The council shall, as soon as possible after the annual election, elect from its membership a mayor pro tem. The mayor pro tem shall act as mayor during the absence or disability of the mayor."

Election of a Mayor Pro Tem

Process

The following outlines the nomination/election process for the appointment of a Mayor Pro Tem.

- Mayor opens the floor to nominations for a Mayor Pro Tem.
 - Only after the Mayor <u>announces</u>, "Nominations are now open", can members of the City Council make nominations.
 - If a member indicates a desire to nominate before the announcement, that member will not be acknowledged.
 - Council members must be acknowledged by the Mayor before voicing their nomination.
 - A council member may only make one nomination.
- Mayor shall accept as many nominations as members of the City Council may wish to submit.
 - o The nominating council member may make comments to describe the reasoning for their nomination.
 - o The Mayor will inquire of each nominee whether they accept the nomination.
- Mayor shall close the nomination process after verifying there are no more nominations received.
 - o At this time, the floor shall be opened for commentary from any member of the City Council.
 - o The item is opened for public comment, if any.
- Mayor shall put nominees to a voice vote in the order nomination(s) were submitted.
 - Once a nominee receives a simple majority vote of those members present, no other nominations will be considered.
 - In the event of a tie vote for any/all nominations received, the nominees previously submitted shall again be presented for election.
