A RESOLUTION OF THE CITY OF DENTON ACCEPTING THE 2025 UPDATE OF THE DENTON ENTERPRISE AIRPORT MASTER PLAN; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, the City of Denton, Texas owns and operates the Denton Enterprise Airport, which serves as a vital component of the national aviation system and regional economy; and

WHEREAS, the Federal Aviation Administration directs all public-use airports, including Denton Enterprise Airport, to periodically update their master plan to ensure safe, efficient, and sustainable development; and

WHEREAS, the Denton Enterprise Airport last updated its master plan in 2015, with said plan's acceptance by the City Council on February 16, 2016; and

WHEREAS, the City of Denton, Texas, selected Coffman Associates, a qualified airport planning firm, to produce an update to the existing Airport Master Plan; and

WHEREAS, Coffman Associates completed the Master plan in conformance with federal guidelines and with extensive analysis and stakeholder engagement; and

WHEREAS, the 2025 Master Plan Update provides a comprehensive vision for the future development of Denton Enterprise Airport, addressing airside and landside facilities, environmental considerations, financial planning, and land use compatibility; and

WHEREAS, the completed 2025 Airport Master Plan Update was reviewed by the Airport Advisory Board and City Council, with both bodies recommending the final plan be considered for acceptance by the City Council; NOW, THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY RESOLVES:

SECTION 1. The findings and recitations contained in the preamble of this ordinance are incorporated herein by reference.

SECTION 2. The 2025 Airport Master Plan Update is accepted as the official planning document to guide future development at Denton Enterprise Airport.

SECTION 3. City staff are authorized to submit the 2025 Master Plan Update to the Federal Aviation Administration for review and approval; and

SECTION 4. This resolution shall become effective immediately upon its passage and approval.
