SUBJECT

Consider adoption of an ordinance of the City of Denton, a Texas home-rule municipal corporation, authorizing the City Manager to execute a contract with LexisNexis Risk Solutions FL Inc., through the Department of Information Resources (DIR) Cooperative Contract No. DIR-CPO-5255 for the purchase of Accurant Virtual Crime Center system, including subscription-based computer assisted investigative research services and related products for the Police Department; providing for the expenditure of funds therefor; and providing an effective date (File 8731 – awarded to LexisNexis Risk Solutions FL Inc., in the five (5) year not-to-exceed amount of \$123,324.00).

STRATEGIC ALIGNMENT

This action supports Key Focus Area: Support Healthy and Safe Communities.

INFORMATION/BACKGROUND

The Police Department has used the Accurant Virtual Crime Center (AVCC) system since 2016. It started as a robust crime analytical system that integrated with the Computer Aided Dispatch and Records Management System (CAD/RMS) and later included the Accurant search tool in 2018. The crime analytic tool provides geospatial crime mapping capabilities to allow our officers and crime analysts to retrieve consolidated historical data with a few clicks. AVCC provides regional and national crime data sharing which assists crime analysis to develop investigative leads.

This contract includes subscription-based computer-assisted investigative research services and related products such as Accurant for LE, Accurant Virtual Crime Center, Real-Time phones, Real-Time MVR, VIR, Jail booking and Email, up to 5 interfaces, and unlimited training for all modules.
