- Required by U.S. Dept. of Housing and Urban Development (HUD) to complete 5-year Consolidated Plan for Housing and Community Development, and annual Action Plan
- Currently operating under the 2023-2027 Consolidated Plan and proposing activities for the 2025 Action Plan for Housing and Community Development
