REGISTRATION GUIDELINES FOR ADDRESSING THE BOARD OF ETHICS

Citizens are also able to participate in the following way (NOTE: Other than public hearings, citizens are only able to comment one time per agenda item; citizens cannot use both methods to comment on a single agenda item. Public comments are not held for work session reports.):

• eComment – On November 1, 2024, the agenda was posted online at https://tx-denton.civicplus.com/242/Public-Meetings-Agendas. Once the agenda is posted, a link to make virtual comments using the eComment module will be made available next to the meeting listing on the Upcoming Events Calendar. Within eComment, citizens may indicate support or opposition and submit a brief comment about a specific agenda item. Comments may be submitted up until the start of the meeting at which time the ability to make an eComment will be closed. Similar to when a citizen submits a white card to indicate their position on an item, the eComments will be sent directly to members of the Board of Ethics and recorded by the Secretary.

Members review comments received in advance of the meeting and take that public input into consideration prior to voting on an agenda item. The Chair will announce the number of Comment Cards submitted in support or opposition to an item during the public comment period. Comments will not be read during the meeting. The Secretary will reflect the number of comments submitted in favor/opposition to an item, the registrant's name, address, and (summary of) comments within the Minutes of the Meeting, as applicable.

BACKGROUND

The Board of Ethics gave direction to discuss the Burden of Proof section of the Ethics Ordinance on August 5, 2024, and stated it that it was their highest priority to remove the Burden of Proof because they believe it deters potential Complainants from submitting Ethics Complaints.

The City Council previous considered and rejected a proposal from the Board of Ethics to:

- 1. Remove Sec. 2-2281(c)(4) from the Ethics Ordinance; and
- 2. Eliminate the requirement for a Complainant to appear at an Evidentiary Hearing for an Actionable Ethics Complaint.

In general, this proposal seemed to be rejected because the City Council was concerned that removing the requirement for the Complainant to appear at an Evidentiary Hearing would increase the number of frivolous complaints.

Previous research indicated that most other benchmark cities do not have a specific ordinance section stating where the "burden of proof" rests. However, many require that the Complainant appear at an evidentiary hearing of some kind, especially when the municipality does not have an independent investigatory function for ethics complaints, like the City of Denton.

During the October 7, 2024, Board of Ethics meeting, the Board of Ethics discussed reasons that the burden of proof concept should be removed from the proposal. These reasons were consolidated in Exhibit 2 for the Board's review.

OPTIONS

The following options are presented to help guide discussion based on Staff's understanding of the Board and the City Council's concerns but are not intended to limit the Board's direction in any way.

- 1. Bring the same proposal back to the City Council with additional information explaining why the change is needed.
- 2. Eliminate the Burden of Proof section in the Ethics Ordinance and leave the Rules of Procedure the same (i.e., still require the Complainant to appear or the complaint must be dismissed).

- 3. Eliminate the Burden of Proof section in the Ethics Ordinance and amend the Rules of Procedure to allow the Board of Ethics to proceed if the Complainant does not appear if there is sufficient evidence. Continuing without the Complainant could require a simple or two-thirds majority vote.¹
- 4. Do not propose an amendment.

PRIOR ACTION/REVIEW (Council, Boards, Commissions)

Jun. 4, 2024: City Council considered and rejected a proposal from the Board of Ethics to remove Sec. 2-2281(c)(4) from the Ethics Ordinance and eliminate the requirement for a Complainant to appear at an Evidentiary Hearing for an Actionable Ethics Complaint.

¹ This procedural change may help resolve a separate procedural issue regarding how to process Ethics Complaints submitted anonymously, as allowed by Sec. 2-272(a) of the Ethics Ordinance.

Reasons to remove burden of proof on complainant from Denton's code:

- Denton's code is only one in Texas that places burden on complainant
- All other codes are silent on burden of proof
- Puts focus on complainant instead of merits of ethical complaint
- Chilling effect on complainants who could face frivolity finding
- Weakens constituent's perspective; takes out voices that could be more objective
- Dismisses anyone lacking information, resources or means to pursue complaints
- Fear based on council's lack of understanding about code's purpose
- Recusal demonstrates transparency; avoids appearance of conflict of interest
- Fear of weaponizing code that is already weaponized between council members

Recommended Changes for Denton's Ethics Ordinance

- Remove City ethics ordinance section 2-273 (a) and replace with City employees ethical code Section I Conflicts of Interest and II Private interest
- 2) Look at city ordinance section 2-273 (b) (c) and (d) to determine if they still fit in the resulting document
- 3) Replace 'employee' with 'city official' wherever it occurs.
- 4) Remove all references to pending matter from ethics code.
- 5) Remove all reference to 'burden of proof' from city ethics ordinance.
- 6) Remove duty to report Section 2-272 (a) from city ethics ordinance.
- 7) Renumber everything as appropriate.
- 8) Add: City council members should not contact Board of Ethics members about BoE matters.
- 9) Add: Potential board members should be interviewed and selected by a full Board of Ethics panel.

The reason is that board members should not have a particular attachment to a council member.

Council Member Request: ### Council Work Session Pitch

I propose we hold a medium-to-low priority work session to set the scope and timelines for a Board of Ethics and staff review & report on appropriate policies for council interactions with petitioners, applicants, and partners.

Specific Objectives

Establish guidance to ensure consistency and transparency in how we interact with applicants that may come before council, including but not limited to developers. Completely ethical but different interaction styles among council members can lead to unintended public misperceptions of appropriateness.

Current Policies

I recommend the Board of Ethics use model codes from CityEthics.org, ICMA.org, and AICP.org as a foundation for any recommended guidelines or policies.

Desired Outcomes

Our goal is to develop template behavior recommendations to guide council members in their interactions.

Stakeholder Involvement

I suggest the Board of Ethics lead this review to provide for impartiality. I recommend they decide on any necessary stakeholder engagement, including the council and the Board of Ethics itself.
