SUBJECT: Low Noise Fireworks

Low noise fireworks are not silent, but they produce less noise than traditional fireworks. Traditional fireworks range from 140 to 170 decibels, while low noise fireworks are around 70 to 90 decibels. Amplified sound exceptions are required for events with sound over 65 decibels on Sunday and over 70 decibels on Monday through Saturday.

Traditional fireworks shows are estimated to cost on average \$1,000 to \$1,200 per minute with larger community shows costing between \$50,000 and \$100,000. City Council approved \$75,300 cash sponsorship and \$14,680 in-kind services for the 2025 Kiwanis Independence Day Jubilee.

A review of online vendors shows fewer low noise than traditional fireworks options. Pricing varies by vendor and low noise categorized options are similar in cost to 20% more than traditional fireworks. Low noise fireworks programs are designed around color effects and choreography and without the loud explosions included in traditional shows. While the cost of low noise fireworks may be slightly more than traditional fireworks, the cost of a professionally designed and choreographed low noise fireworks show is unknown.

Sustainability education and outreach primarily focus on topics such as air quality, land use, waste reduction, transportation, and energy/water conservation and are provided through a variety of events including activities, meetings, presentations, tabling at events, and tours.

### **Total Events for First Half Fiscal Year 2024-2025:**

In the first half of Fiscal Year 2024-2025, Sustainability participated in 86 events with a total attendance of 7,092. In comparison, the first half of Fiscal Year 2023-2024 had a total of 69 events with 4,440 attendees. The 59.7% increase in attendance was from targeted advertising utilizing flyers placed in local libraries, recreation centers, senior centers, and social media. The Sustainability division also produces a quarterly newsletter, which includes upcoming presentations and activities as well as sustainability tips for the upcoming season.

The Sustainability division manages both the Sustainability and Solid Waste & Recycling (SWR) social media accounts. Sustainability uses Facebook and Instagram to reach residents, and SWR uses Facebook, Instagram, Twitter, and Nextdoor. Both accounts have seen an increase in followers during these first two quarters, with the Sustainability Instagram seeing the most growth from 199 to 260, a 30.7% increase in followers.
