Public comments can be given for any item considered by the Charter Review Committee, EXCEPT work session reports or closed meetings. Individuals are only able to comment one time per agenda item and cannot use more than one method to comment on a single agenda item. Public comments are limited to two (2) minutes per speaker, with a maximum of 5 speakers per meeting.

In Person:

To provide in-person comments individuals must be present at the meeting and submit a speaker card (available at the meeting location) to the staff liaison prior to the item being called.

After determining that a quorum is present, the Charter Review Committee of the City of Denton, Texas, will convene in a meeting on Thursday, July 25, 2024, at 5:30 p.m. in the Development Services Center Training Rooms 3, 4 and 5 at 401 Elm Street, Denton, Texas at which the following items will be considered:
