SUBJECT

Consider adoption of an ordinance repealing ordinance No. 2003-258, and subsequent amendments of Ordinance No. 2011-042, Ordinance No. 2014-009, ordinance No. 2015-074, Ordinance No. 2016-249, and Ordinance No. 2017-203, relating to the creation, appointments, and duties of the Economic Development Partnership Board (The "Board") to amend the qualifications of board members; repealing all conflicting ordinances and portions thereof; and providing an effective date.

BACKGROUND

The Economic Development Partnership Board (EDPB) was established, following the TIP Strategies Economic Development Plan recommendations, on August 19, 2003 (Ordinance No. 2003-258). The EDP board is responsible for implementation of economic development strategies; making recommendations regarding both City and Chamber economic development annual action plans and budgets; and reviewing prospect incentive packages and making recommendations to City Council.

The original ordinance established the EDPB with seven voting members (two City Council members, two Chamber Board of Directors members, two members from the top 20 City of Denton ad valorem or sales taxpayers, the President of the University of North Texas (UNT), and the Denton City Manager and Chamber President as ex-officio members. It has been amended four times:

- 2011-042 added two members, one with general aviation knowledge or experience and an at-large position with specific knowledge, skills, and abilities to assist in the functions and responsibilities of the board; expanded the duties of the board to include branding and marketing for the Denton Municipal Airport and to include duties related to Airport economic development incentives;
- 2014-009 added the Denton Independent School District Superintendent as an ad-hoc non-voting member;
- 2015-074 added two members, one nominated by the Denton Black Chamber of Commerce and one nominated by the Denton Hispanic Chamber of Commerce.
- 2016-249 added one member, the Texas Woman's University (TWU) President and Chancellor

On July 18, 2017, a new ordinance incorporating all prior amendments clarifying and refining Economic Development Partnership Board member qualifications, terms, and Board responsibilities was adopted through Ordinance 2017-203.

The EDP Board now has twelve voting and three non-voting members. All voting members except the presidents of UNT and TWU can serve up to three two-year terms; the presidents can serve unlimited terms, but must be re-nominated upon the expiration of each two-year term.

The proposed amendment removes the requirement that the Denton Chamber representative shall be a currently serving Chamber Board member. This change is in line with the Denton Black Chamber of Commerce and Denton Hispanic Chamber of Commerce requirements. The ordinance includes the following:

Two members will be nominated by the Denton Chamber of Commerce Board of Directors. The members must reside or work in the City of Denton.
