AN ORDINANCE OF THE CITY OF DENTON, A TEXAS HOME-RULE MUNICIPAL CORPORATION, REJECTING ANY AND ALL COMPETITIVE STATEMENTS OF QUALIFICATIONS UNDER RFQ 8061 FOR THE ASSET MANAGEMENT VISION FOR THE WATER UTILITIES DEPARTMENT; AND PROVIDING AN EFFECTIVE DATE (RFQ 8061).
