AN ORDINANCE OF THE CITY OF DENTON, TEXAS, *NUNC PRO TUNC*, CORRECTING A SCRIVENER'S ERROR IN THE ORDINANCE NUMBER ON THE SIGNED COPY OF ORDINANCE NO. A23-0003c; PROVIDING FOR A SAVINGS CLAUSE AND AN EFFECTIVE DATE. (A23-0002c)

WHEREAS, on December 12, 2023, the City Council approved Ordinance No. A23-0003c annexing approximately 7.25 acres of land, generally located 224 feet north of East McKinney Street and approximately 1,140 feet east of Trinity Road; and

WHEREAS, City Staff discovered an inadvertent Scrivener's error in the assigned Ordinance Number of the signed copy of Ordinance No. A23-0003c, which resulted in an ordinance number that did not match the assigned project number; and

WHEREAS, City Staff requests that the inadvertent mistake be revised to correctly reflect Ordinance Number, as provided in Exhibit A; and

WHEREAS, the City Council has the inherent power to retroactively correct such mistakes to accurately reflect its official actions; and

WHEREAS, the City Council finds that said corrections are in the best interest of the citizens of the City of Denton and should be adopted as stated herein; NOW, THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

SECTION 1. The findings and recitations contained in the preamble of this ordinance are incorporated herein by reference and found to be true.

SECTION 2. The Ordinance Number of Ordinance No. A23-0003c is hereby amended as shown on Exhibit A to reflect the appropriate ordinance number, which corresponds with the applicable City-assigned project number.

SECTION 3. All other provisions of Ordinance No. A23-0003c not specifically amended or deleted herein shall continue in full force and effect from the date of original passage on December 12, 2023.

SECTION 4. This Ordinance shall become effective immediately upon its passage and approval.

ORDINANCE NO. A23-0002c

AN ORDINANCE OF THE CITY OF DENTON, TEXAS ANNEXING APPROXIMATELY 7.25 ACRES OF LAND, GENERALLY LOCATED 224 FEET NORTH OF E. MCKINNEY STREET AND 1, 140 FEET EAST OF TRINITY ROAD TO THE CITY OF DENTON, DENTON COUNTY, TEXAS; PROVIDING FOR A CORRECTION TO THE CITY MAP TO INCLUDE THE ANNEXED LAND; AND PROVIDING FOR A SAVINGS CLAUSE AND AN EFFECTIVE DATE. (A23-0002c)
