#### **SUBJECT**

Consider adoption of an ordinance of the City of Denton granting the Denton Main Street Association a noise exception for the Twilight Tunes Series, which will be held on Thursday, May 2, May 9, May 16, May 23, May 30, June 6, June 13, June 20 and Friday, June 21, 2024 from 6:00 p.m. to 8:00 p.m. on the Courthouse Lawn - 110 W. Hickory Street; and providing an effective date.

#### **BACKGROUND**

The Twilight Tunes Series is organized by the Denton Main Street Association, a 501(c)6 non-profit member organization that works in cooperation with the City of Denton's Economic Development Department. This series serves to showcase local musicians, artists, and performers while also increasing Downtown foot traffic to local businesses. In the past, this spring series has been held at the Downtown Square and the fall series has been held at Wolff's Park.

This free series features local artists, musicians, and performers and invites attendees to enjoy a night out listening to live music and picnic in the park with food and drinks brought from home or from visiting one of the many downtown eateries. Event organizers anticipate 500 to 1,000 attendees at each event.

The Denton Main Street Association requests an exception to the noise ordinance with respect to sound levels from 70 dba to 75 dba on Thursday, May 2, May 9, May 16, May 23, May 30, June 6, June 13, June 20 and June 21, 2024, from 6:00 p.m. to 8:00 p.m. on the Courthouse Lawn - 110 W. Hickory Street.
