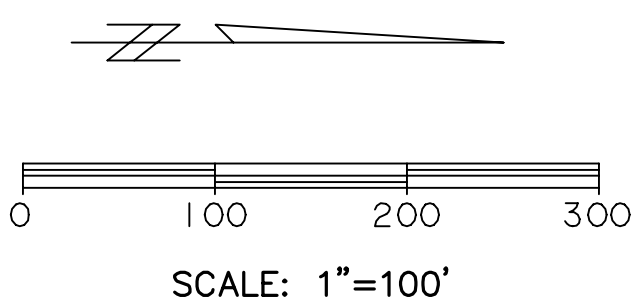


VICINITY MAP
