ORDINANCE NO.

AN ORDINANCE OF THE CITY OF DENTON, TEXAS PROVIDING FOR, AUTHORIZING, AND APPROVING THE EXPENDITURE OF FUNDS FOR THE PURCHASE OF TRAFFIC SIGNAL HARDWARE INCLUDING TRAFFIC SIGNAL CONTROLLERS, VIDEO DETECTION SYSTEMS, BATTERY BACKUP SYSTEMS, AND NETWORK SWITCHES, FOR THE CITY OF DENTON TRAFFIC DEPARTMENT, WHICH IS AVAILABLE FROM ONLY ONE SOURCE AND IN WITH CHAPTER 252.022 OF THE TEXAS ACCORDANCE LOCAL GOVERNMENT CODE SUCH PURCHASES ARE EXEMPT FROM THE REQUIREMENTS OF COMPETITIVE BIDDING; AND PROVIDING AN EFFECTIVE DATE (FILE 6248 AWARDED TO PARADIGM TRAFFIC SYSTEMS IN THE ANNUAL ESTIMATED AMOUNT OF \$290,000 FOR A THREE (3) YEAR NOT TO EXCEED AMOUNT OF \$870,000).

WHEREAS, <u>Section 252.022 of the Local Government Code</u> provides that procurement of items that are only available from one source, including; items that are only available from one source because of patents, copyrights, secret processes or natural monopolies; films, manuscripts or books; electricity, gas, water and other utility purchases; captive replacement parts or components for equipment; and library materials for a public library that are available only from the persons holding exclusive distribution rights to the materials; and need not be submitted to competitive bids; and

WHEREAS, the City Council wishes to procure one or more of the items mentioned in the above paragraph; NOW, THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

<u>SECTION 1.</u> The following purchase of materials, equipment or supplies, as described in the "File" listed hereon, and on file in the office of the Purchasing Agent, are hereby approved:
