FIRST AMENDMENT TO CONTRACT #5424

THIS FIRST AMENDMENT TO CONTRACT (hereafter the "First Amendment") to the certain Contract awarded to LCG CONSULTING, (hereafter the "Agreement") in the original not-to-exceed amount of \$309,000, which was heretofore executed on February 4, 2014, and was approved within the delegated authority of the City of Denton City Council; and said Agreement was heretofore entered into by and between the City of Denton, Texas, a Texas Municipal Corporation with its offices at 215 East McKinney Street, Denton, Texas 76201 (hereafter the "CITY"); and LCG CONSULTING, whose address is 4962 El Camino Real, Suite 112, Los Altos, CA 94022, (hereinafter referred to as "SUPPLIER,"); and

Contract 5424 was awarded for Forward Market Modeling Software services. SUPPLIER has begun providing initial services called for in the original Agreement; and the City deems it necessary to further expand the services by SUPPLIER to the CITY, to provide PLATO Database License for the 2017 ERCOT Database annual license for an additional not-to-exceed amount of \$10,000, for an aggregate of \$319,000, (Exhibit A).

NOW THEREFORE, the CITY and SUPPLIER (hereafter collectively referred to as the "Parties"), in consideration of their mutual promises and covenants, as well as for other good and valuable considerations, do hereby AGREE to the following:

The Parties hereto agree, that except as specifically provided for by this First Amendment, that all of the terms, covenants, conditions, agreements, rights, responsibilities, and obligations of the Parties, set forth in both the Agreement and now the First Amendment shall be, and will remain in full force and effect.
