With no other speakers, Robinson read the cards.

Board Member Russell asked about the electric lines going in and out. Williams answered

there will be eight feeders, distribution lines will go out underground and come out on Sherman Drive.

Williams also spoke to the health hazards adding that working with electricity if there were any real hazards it would be evident in the employees. There hasn't been any substantiated health problems with transmission lines or substations.

When the Kings Row Substation was built is was out in the country and houses are built right up close to this substation. That is one of the reasons DME would like to get ahead of the growth and put this out from homes.

Board Member Jackson asked where the electric lines will come out on Sherman Drive.

Williams responded half would come out at Sherman Drive and half at Hartlee Field Road, the design is not complete on exactly where the lines would come out. There are no plans for lines to come out over homes. There are no served areas over the homes. If at a later date there are, the lines would come out no matter where the substation is located.

There was a question from a citizen in the audience regarding construction traffic on Hartlee Field Road. Williams answered he is talking with his staff about making an access road that is directly west of the top line of the yellow site. This access road would be out to FM428 and not on Hartlee Field Road. There has been no commitments on this just yet.

Board Member Jackson recommended the yellow site with provisions to construct the substation on the northern portion of that property and for DME to investigate the access road option. There was a second by Board Member Parker. Vote 7-0 approved.

Board Member Carroll stated that all citizens that were at this meeting spoke in opposition of the yellow site except one gentleman. Unfortunately the yellow site seems like the best option. He realizes how unsightly they are buy living in close proximately to one. That is also the price we have to pay for electricity. Carroll also expressed to the citizens to hold the City responsible for what has been promised whether it be the access road or aesthetics.

Chair Robinson thanked all the citizens that came out to the meeting.
