

NOTICE OF PUBLIC MEETING

**Interstate Highway (IH) 35
Proposed Improvements to IH 35 from United States Highway (US) 380
To 0.7 mi. north of Farm to Market (FM) 3002
CSJs: 0195-03-087, 0195-02-074, 0195-01-116**

The Texas Department of Transportation (TxDOT) will conduct a public meeting for proposed improvements to IH 35 from US 380 to 0.7 miles north of FM 3002 in Denton and Cook Counties, Texas, a distance of approximately 15.12 miles. The Preliminary Design Schematic will be presented, as well as project location information. **The meeting will be held on Thursday, June 22nd, 2017 from 6:00 pm to 8:00 pm at Sanger High School, located at 100 Indian Lane, Sanger, TX 76266.** Representatives from TxDOT and project consultants will be available to answer questions about the proposed project. It will be conducted in an informal open house format with no formal presentation.

The proposed improvements would reconstruct and widen IH 35 from two main lanes in each direction to three main lanes in each direction and construct continuous one-way frontage roads (two lanes in each direction). The existing interchanges would be reconstructed and the existing two-way frontage roads would be converted to a one-way operation. The improvements that are proposed at the cross streets would accommodate one-way frontage road operations and turnarounds.

Maps depicting the proposed project's location and preliminary geometric design will be available for viewing at the public meeting. All interested citizens are invited to attend the public meeting. Written comments from the public regarding this project are requested and will be accepted for a period of 15 calendar days following the public meeting. 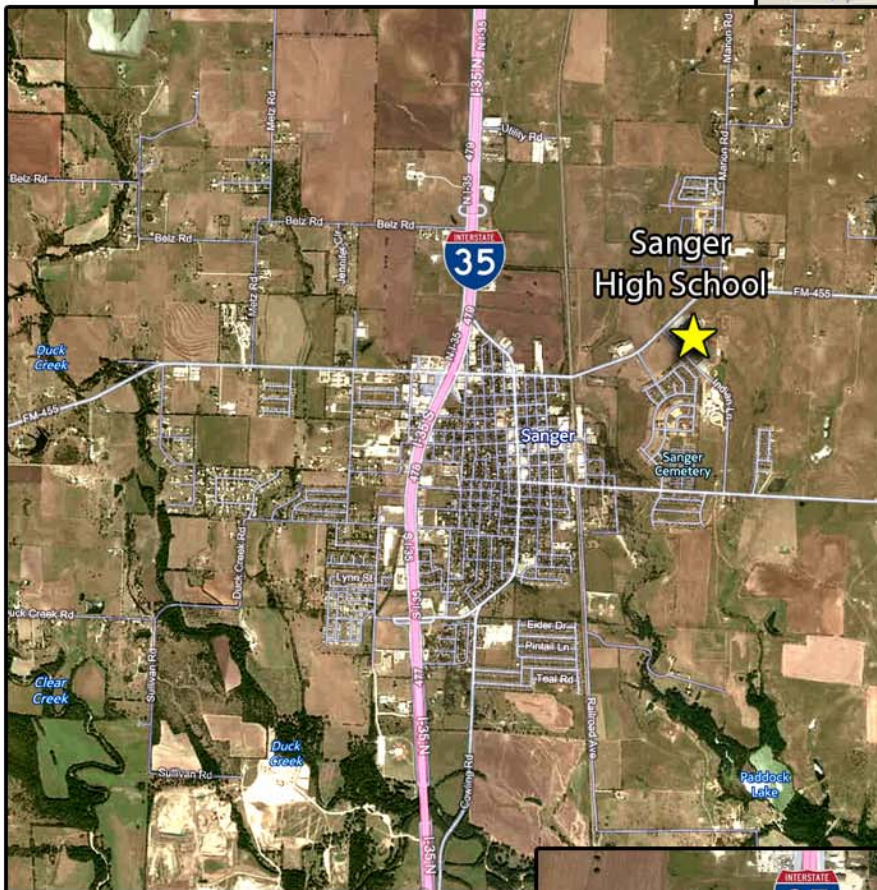
