Denton Chamber Econ. Dev. Goals and accomplishments

Highlight Accomplishments for 16-17

- Fulfilled everything to date as stated in the City/Chamber ED contract
- Currently sit at 85 leads with 47 proposals sent or engaged (only halfway through fiscal year)
- 11 site visits from 9 different companies (Peanut Butter, Southern Comfort, Penmountain, Chicken, Rail Load, Columbus Balbo, Coil Engineering, Trim, and Balk). Only had 9 total site visits the entire year last year, and only 5 by this same time period.
- Conducted all target marketing trips
- Raised the number of private investors in the Partnership (up to 63)
- Raised the amount of private investment in the Partnership

Highlight Goals for 17-18

- Fulfill everything as stated in the City/Chamber ED contract
- Increase the number of outgoing proposals
- Increase number of site visits
- Raise number of private investors to 65
- Raise the amount of private investment in the Partnership

Current

- Perform duties of the office per City/Chamber contractual agreement
- Act as the gatekeeper with site location consultants and prospect activity, that doesn't require a formal RFP issued from the Office of the Governor or the Dallas Regional Chamber
- Conduct all marketing/prospect development activities
- Maintain EDP website, marketing materials, and promotional items
- Maintain ED Partnership investor relations
- Maintain private sector/investor funds for additional budget dollars

Propose

- Perform duties of the office per City/Chamber contractual agreement
- Attend and participate in activities and organizations with local, metro, state, regional and international organizations stipulated in the annual agreement
- Continue with target marketing activities and attend as many site location consultant activities as budget will allow
- Increase social and web-based activities
- Implement a CRM system with City ED staff as budget allows

- Eliminate duplication of services 1) Chamber Office of ED handles all incoming prospects that are not direct RFP requests from the Office of the Governor and the Dallas Regional Chamber, as well as all prospects generated through marketing activities. 2) The Chamber maintains a separate, private budget to conduct additional marketing activities not specified in the public ED budget, along with maintaining all memberships and economic development investor relations.
