AN ORDINANCE ACCEPTING COMPETITIVE BIDS AND AWARDING A PUBLIC WORKS CONTRACT FOR THE CONSTRUCTION OF THE MAYHILL ROAD WIDENING AND IMPROVEMENTS PROJECT FOR THE CITY OF DENTON WITH GEOGRAPHICAL LIMITS FROM US 380/UNIVERSITY DRIVE SOUTH TO 500' NORTH OF EDWARDS ROAD; PROVIDING FOR THE EXPENDITURE OF FUNDS THEREFOR; AND PROVIDING AN EFFECTIVE DATE (IFB 6389C-AWARDED TO ZACHRY CONSTRUCTION CORPORATION IN THE NOT-TO-EXCEED AMOUNT OF \$35,877,414.52.)

WHEREAS, the City has solicited, received, and tabulated competitive bids for the construction of public works or improvements in accordance with the procedures of State law and City ordinances; and

WHEREAS, the City Manager or a designated employee has received and recommended that the herein described bids are the lowest responsible bids for the construction of the public works, or improvements described in the bid invitation, bid proposal, and plans and specifications therein; NOW, THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

<u>SECTION 1</u>. The following competitive bids for the construction of public works or improvements, as described in the "Bid Invitation", "Bid Proposal" or plans and specifications on file in the Office of the City's Purchasing Agent filed according to the bid number assigned hereto, are hereby accepted and approved as being the lowest responsible bids:

SECTION 2. The acceptance and approval of the above competitive bids shall not constitute a contract between the City and the person submitting the bid for construction of such public works or improvements herein accepted and approved, until such person shall comply with all requirements specified in the Notice to Bidders including the timely execution of a written contract and furnishing of performance and payment bonds, and insurance certificate after notification of the award of the bid.

<u>SECTION 3</u>. That the City Manager is hereby authorized to execute all necessary written contracts for the performance of the construction of the public works or improvements in accordance with the bids accepted and approved herein, provided that such contracts are made in accordance with the Notice to Bidders and Bid Proposal, and documents relating thereto specifying the terms, conditions, plans, and specifications, standards, quantities, and specified sums contained therein.

<u>SECTION 4</u>. The City Council of the City of Denton, Texas hereby expressly delegates the authority to take any actions that may be required or permitted to be performed by the City of Denton under IFB 6389 C to the City Manager of the City of Denton, Texas, or his designee.

<u>SECTION 5</u>. Upon acceptance and approval of the above competitive bid, and the execution of the contract for the public works and improvements as authorized herein, the City Council hereby authorizes the expenditure of funds in the manner and in the amount as specified in such approved bids and authorized contracts executed pursuant thereto.

<u>SECTION 6</u>. That this ordinance shall become effective immediately upon its passage and approval.
