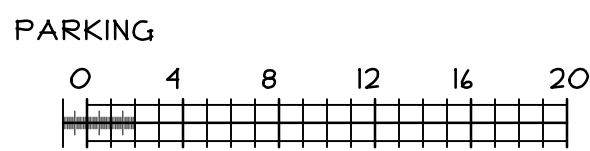
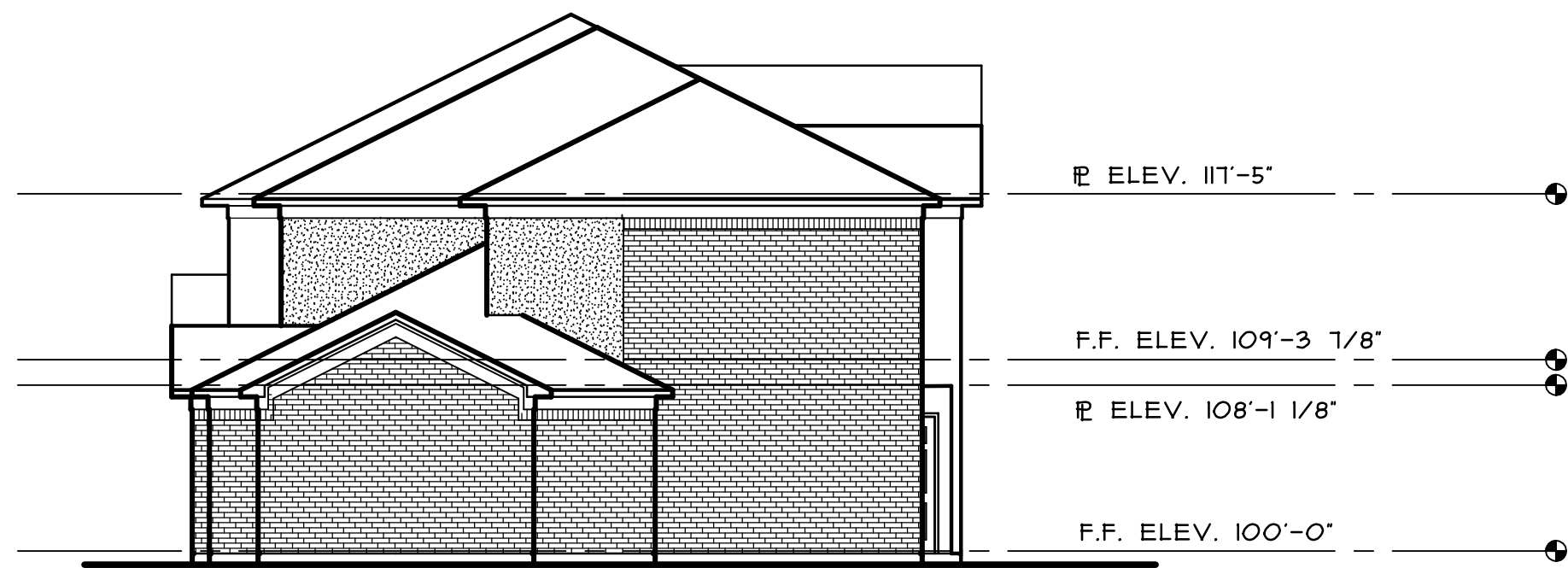


1 BUILDING 1 FRONT ELEVATION

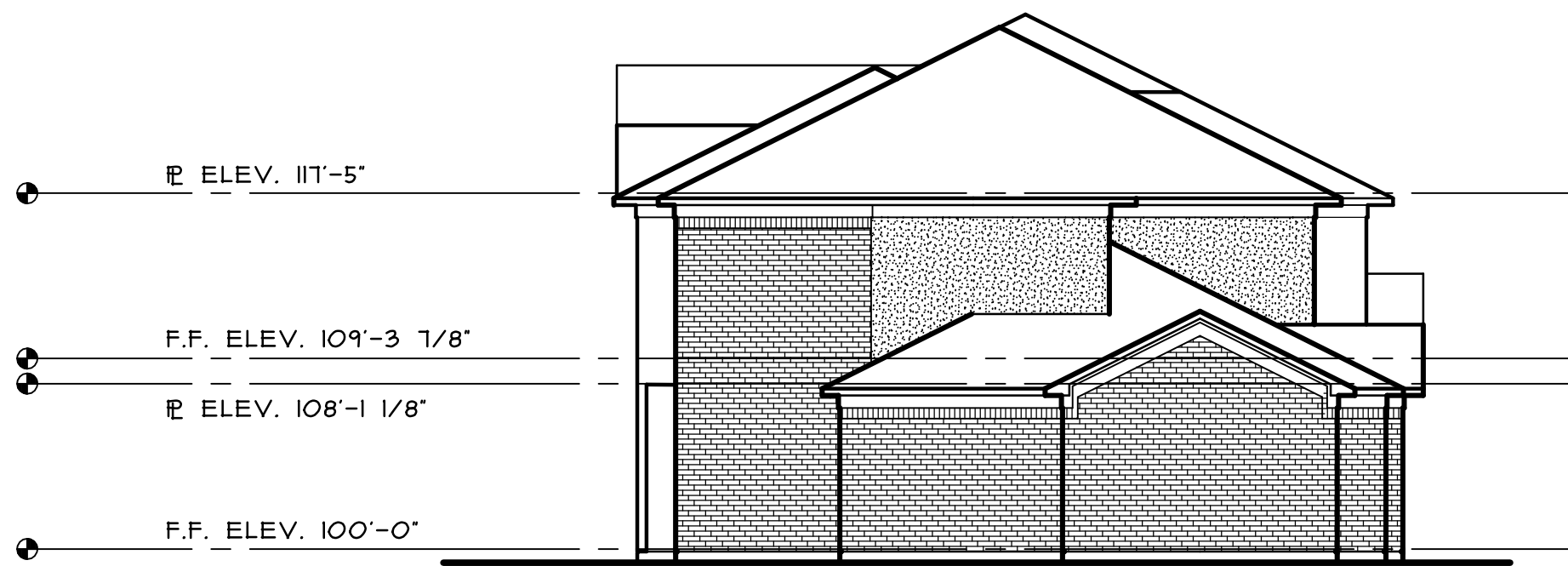
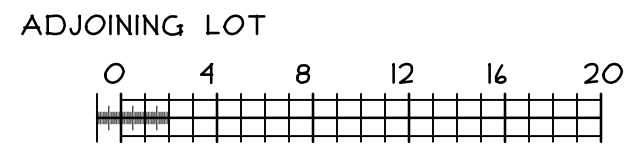

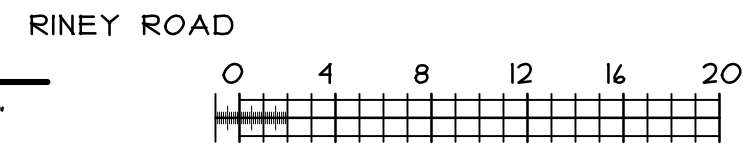

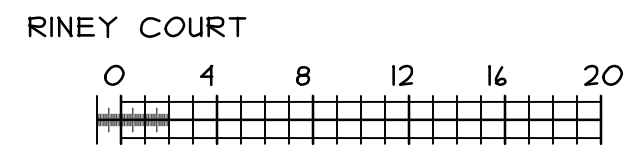

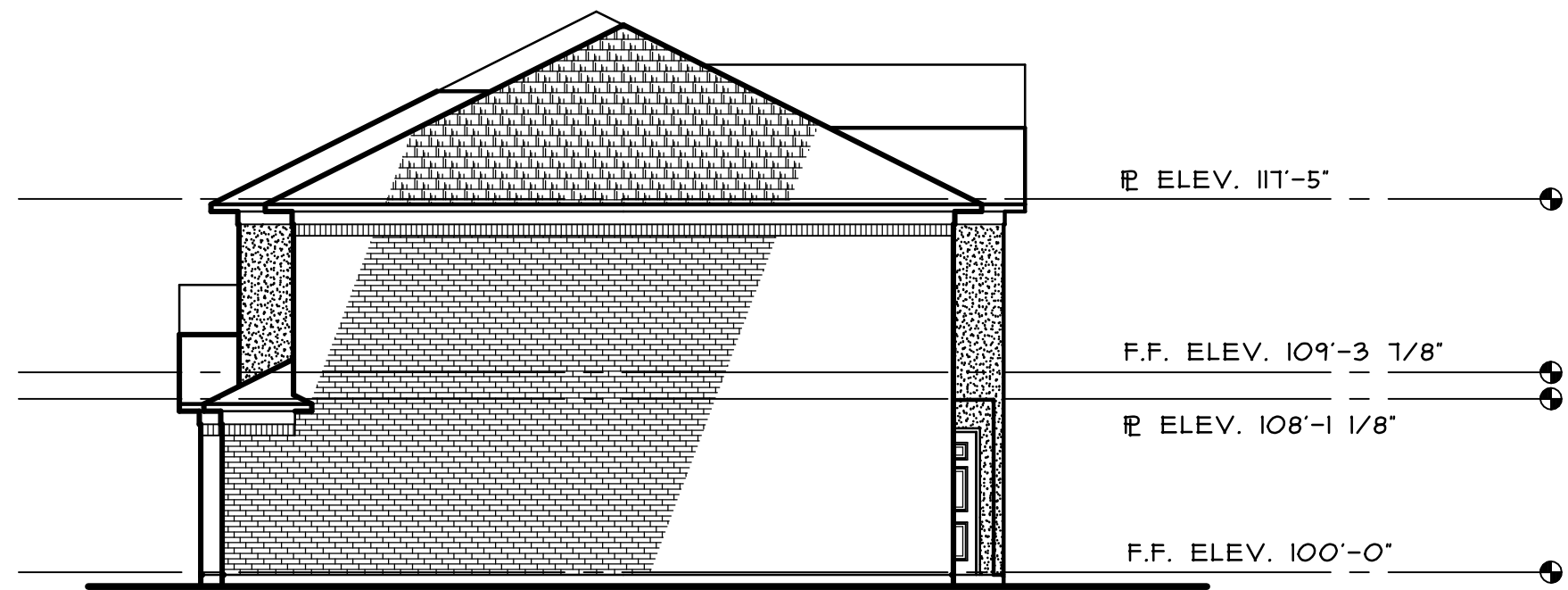
1 BUILDING 2 FRONT ELEVATION

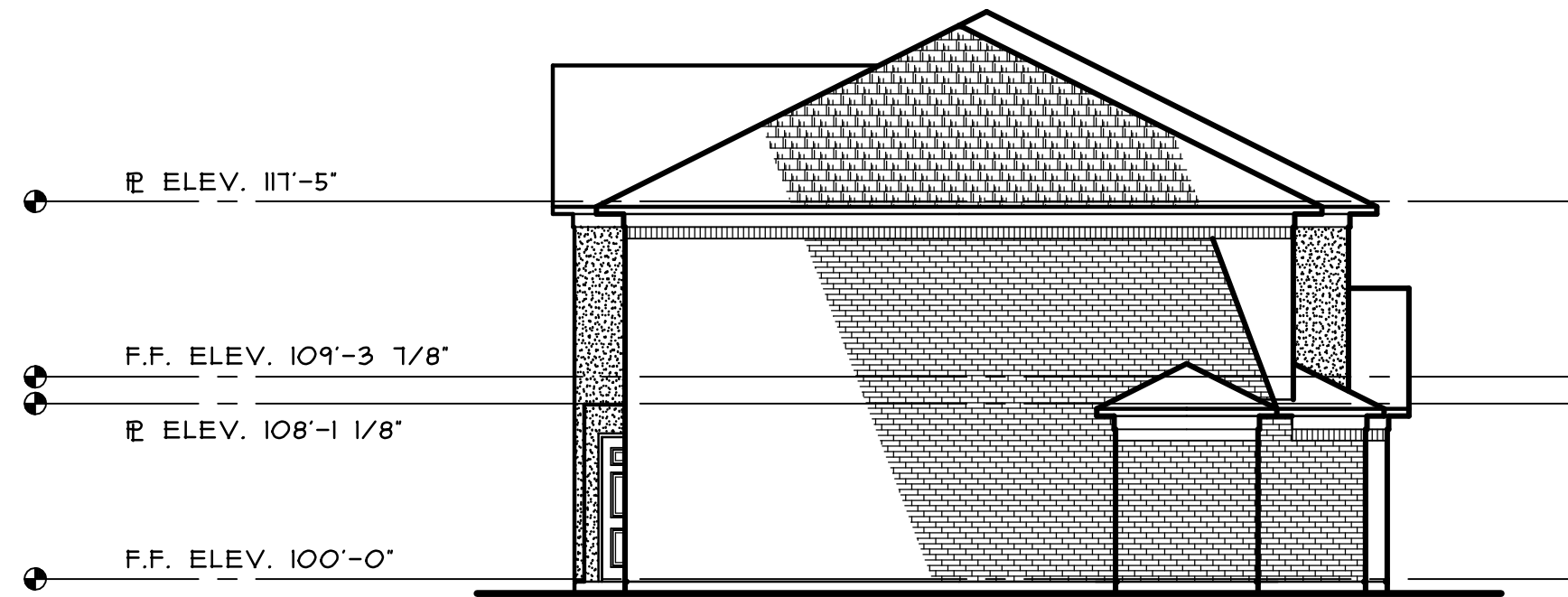

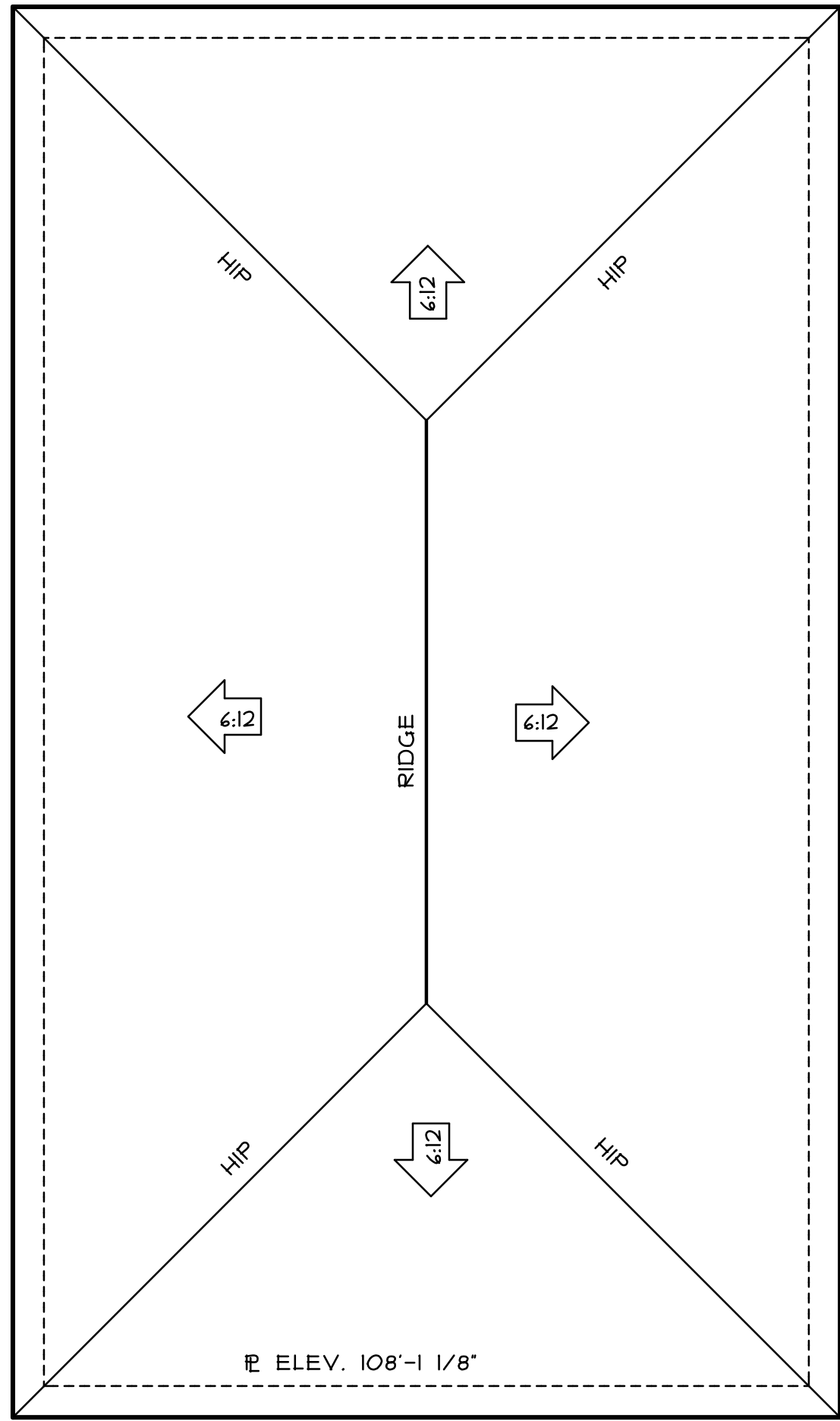

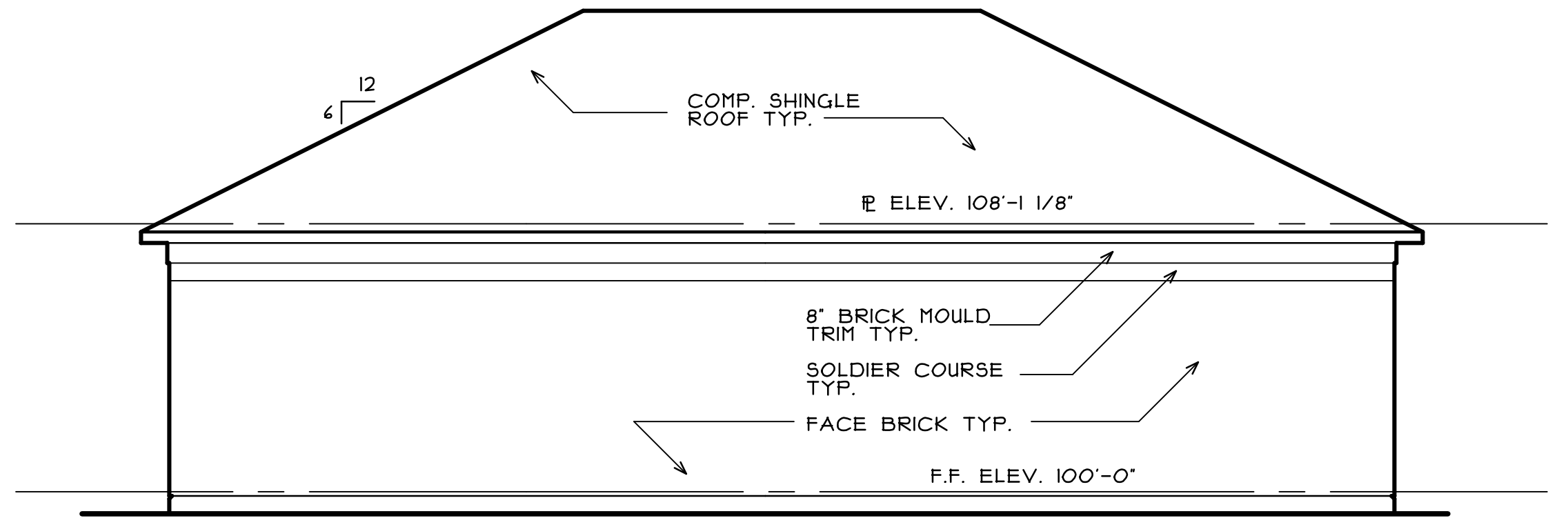
1 FLOOR PLAN - STORAGE

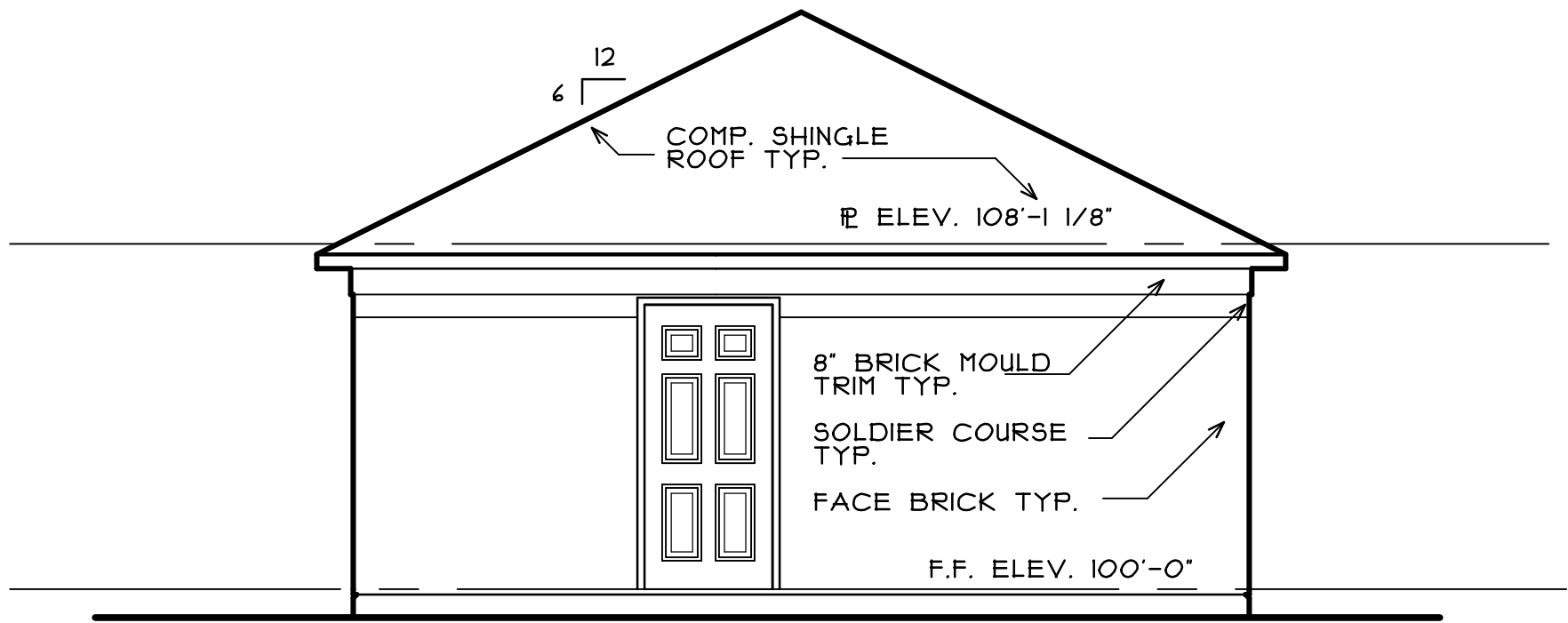
2 ROOF PLAN

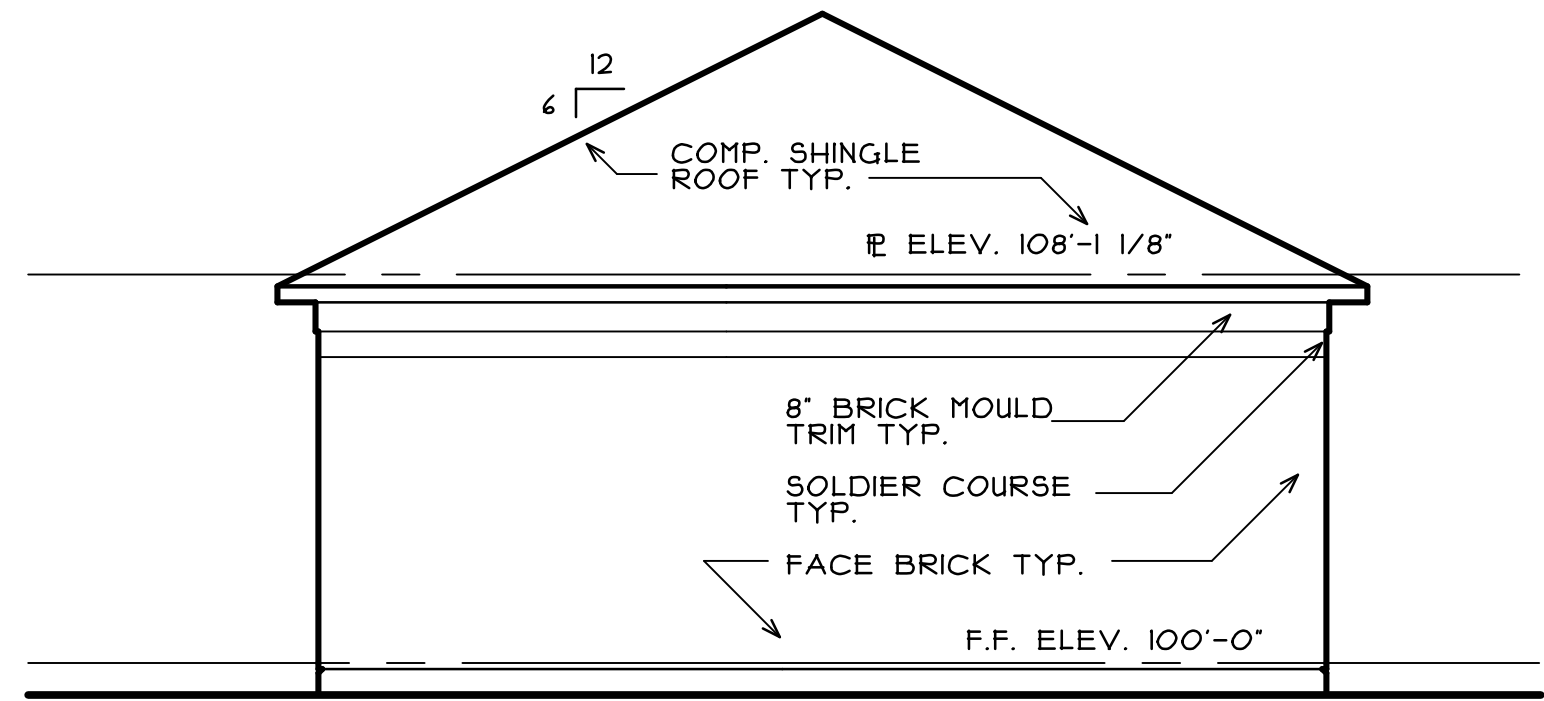
