SUBJECT

Consider adoption of an ordinance of the City of Denton, Texas amending the Fiscal Year 2016-2017 Budget and Annual Program of Services of the City of Denton to allow for adjustments to the General Fund of four million, two hundred five thousand one hundred seventy three dollars (\$4,205,173) for the purpose of funding improvements, equipment and other expenses, the Electric Fund of thirteen million dollars (\$13,000,000) for the purpose of funding higher purchased power expenditures; declaring a municipal purpose; providing a severability clause; providing an open meetings clause; and providing for an effective date.

BACKGROUND

City staff is proposing to amend the City's FY 2016-17 Budget. The FY 2016-17 General Fund proposed budget amendment is for the following items:

• Replacement of Permitting Software (Development Services)	-	\$ 500,000

Staff is proposing to amend the Electric FY 2016-17 budgets to fund higher purchased power expenditures. Denton anticipated the sale of TMPA when developing the FY 2016-17 budget. Since the sale of the TMPA did not occur, purchase power payments made to TMPA in FY 2016-17 were increased to include Denton's share of the TMPA debt charges.

FISCAL INFORMATION

This ordinance will amend the FY 2016-17 Budget and Annual Program of Services to allow for adjustments to the General Fund of \$4,205,173 increasing appropriations from \$114,808,930 to 119,014,103; Electric Fund of \$13,000,000, increasing appropriations from \$173,408,320 to \$186,408,320.

STRATEGIC PLAN RELATIONSHIP

The City of Denton's Strategic Plan is an action-oriented road map that will help the City achieve its vision.
