SUBJECT

Consider adoption of an ordinance approving a First Amendment to a Commercial Operator Airport Lease Agreement between the City of Denton, Texas and James and Nancy Huff for assignment to US Trinity Holdings, LLC; and providing an effective date. Council Airport Committee recommends approval (3 - 0)

BACKGROUND

The James and Nancy Huff lease agreement is a 30-year agreement dated July 18, 2017, effective August 1, 2017 to August 31, 2047, with two, five year options to extend the term to August 31, 2057. The 13,800 square foot leasehold is currently vacant. Mr. Huff is working with Airport Staff to enter into another lease agreement on the Airport to facilitate his 50' x 60' hangar development.

US Trinity Holdings, LLC is in the process of acquiring the HTA Aviation leasehold, which is immediately north of the Huff leasehold, through a lease assignment. US Trinity Holdings, LLC. is interested in acquiring the Huff leasehold in order to expand the HTA leasehold hangar capacity to accommodate four existing based aircraft, as well as accommodate additional aircraft as needed. The proposed assignment does not include any renegotiated terms or conditions.

OPTIONS

1. Approve the proposed ordinance to assign the lease agreement as requested by James W. and Nancy C. Huff and assignee US Trinity Holdings, LLC.
2. Assign James W. and Nancy C. Huff lease to US Trinity Holdings, LLC with additional direction.
3. Take no action at this time.

ESTIMATED SCHEDULE OF PROJECT

The assignment will take effect upon Council action.

PRIOR ACTION/REVIEW (Council, Boards, Commissions)

Council approved the lease agreement on August 15, 2017, Ordinance 2017-224.
Council Airport Committee recommended approval (3-0) on October 5, 2017.

FISCAL INFORMATION

This property lease is for 13,800 square feet of land for an annual lease rate of \$3,726.00. The annual lease rate includes annual Consumer Price Index adjustment, will be adjusted on July 1, 2019.
