SUBJECT

Consider adoption of an ordinance approving a Second Amendment to a Commercial Operator Airport Lease Agreement between the City of Denton, Texas and HTA Aviation for assignment to US Trinity Holdings, LLC; and providing an effective date. Council Airport Committee recommends approval (3 - 0)

BACKGROUND

The HTA Aviation lease agreement is a 40-year agreement dated September 18, 2012, effective October 1, 2012 to September 30, 2052. The 28,630 square foot leasehold includes one, 10,400 square foot hangar, apron and auto parking.

US Trinity Holdings, LLC is currently a based customer of US Jet Center and is interested in acquiring their own hangar facility to accommodate four existing based aircraft. US Trinity Holdings, LLC is also interested in acquiring the James and Nancy Huff leasehold immediately south of the HTA Aviation leasehold, to expand the hangar capacity to possibly accommodate additional aircraft as needed. The proposed assignment does not include any renegotiated terms or conditions.

OPTIONS

- 1. Approve the proposed ordinance to assign the lease agreement as requested by HTA Aviation and assignee to US Trinity Holdings, LLC.
- 2. Assign HTA Aviation lease to US Trinity Holdings, LLC with additional direction.
- 3. Take no action at this time.

ESTIMATED SCHEDULE OF PROJECT

The assignment will take effect upon Council action.

PRIOR ACTION/REVIEW (Council, Boards, Commissions)

Council approved the lease agreement on September 18, 2012, Ordinance 2012-236.

Council approved the first amendment on June 18, 2013, Ordinance 2013-149.

Council Airport Committee recommended approval (3-0) on October 5, 2017.

FISCAL INFORMATION

This property lease is for 28,630 square feet of land for a current annual lease rate of \$8,015.04. The annual lease rate includes annual Consumer Price Index adjustment and will be adjusted on August 7, 2018.
