AN ORDINANCE OF THE CITY OF DENTON, TEXAS APPROVING A CONSENT TO ASSIGNMENT OF AN AIRPORT LEASE BETWEEN JAMES AND NANCY HUFF AND US TRINITY HOLDINGS, LLC.; AND PROVIDING AN EFFECTIVE DATE.

SECTION 1. The findings and recitations contained in the preamble of this Ordinance are incorporated herein by reference
SECTION 2. The City Manager or his designee is hereby authorized to execute a Lease Assignment of the Pad Site at 4901 Lockheed Lane, Denton Enterprise Airport in the form attached hereto as Exhibit A and made a part of this Ordinance for all purposes.


