OBJECTIVES and ACTION STEPS

- **Implement Total Impact 2.0 fiscal and economic impact analysis program**
 - Action step – Use Total Impact to analyze all RFPs and incentive requests (Erica & Christina)
 - Deadline – July 2017 (COMPLETE)
- **Create incentive contract templates**
 - Action Step – Work with Legal Department or outside counsel to complete templates (Erica & Caroline)
 - Deadline – December 2017
- **Revise City of Denton Economic Development Incentive Policy and application**
 - Action step – Update application to capture information needed for DME and to perform impact analysis using Total Impact (Erica & Caroline)
 - Deadline – September 2017 (COMPLETE)
 - Action step – Update Incentive Policy to include the Investment and Airport Grant Programs and incorporate new tax tools; bring to Council for review (Erica & Caroline)
 - Deadline – October 2017
- **Collaborate with the Department of Development Services on development process improvement**
 - Action Step – Participate on the Strike Team (Caroline)
 - Deadline – Ongoing
- **Enhance existing business retention and expansion program**
 - Action Step – Begin working with Fry Street Area merchants to implement a business support program (Julie)
 - Deadline – August 2017 (COMPLETE)

Foster Denton's thriving culture of business, technology, and artistic creation and innovation by building on our higher education and community resources.

OBJECTIVES and ACTION STEPS

- **Leverage Stoke Denton's momentum to recruit or expand tech and tech-enabled start-ups**
 - Action Step – Schedule and hold monthly meetings with Stoke director to identify prospects (Caroline)
 - Deadline – ongoing

- **Encourage business participation in the S.H.O.P. Denton, Small Business Saturday, and National Small Business Week programs and events**
 - Action Step – Develop a marketing and communications plan to use social media, the City's website, and additional resources to promote the SHOP program and events to the community. (Christina)
 - Deadline – September 2017 (COMPLETE)

Performance Measure

- 10% increase in business participation in small business programs

Workforce Development

Develop, attract, and keep skilled and talented workers to support existing and future employers.

OBJECTIVES and ACTION STEPS

- **Coordinate Denton Workforce Development Consortium Meetings**
 - Action Step – Set dates and locations for quarterly meetings (Michelle Cunningham)
 - Deadline – August 2017 (COMPLETE)
- **Facilitate local employers' applications for workforce-related grants**
 - Action Step – Identify and contact five local businesses regarding participation in grants (Michelle Cunningham)
 - Deadline – December 2017

- Number of workforce development activities or grants facilitated (12 per year)

 - Action Step -- Meet with the Public Communications Office to develop series (Caroline)
 - Deadline – June 2017 (COMPLETE)
