House Bill 89 - Government Code 2270

VERIFICATION

THIS FIRST AMENDMENT TO CONTRACT 5725 (“Amendment”) by and between the City of Denton, Texas (“City”) and TDC L.L.C. (“Contractor”);

The original Agreement provided for TDC L.L.C. related to supplier of Water Treatment Chemicals for the City of Denton, as is contained in Contract #5725 (on file in the Purchasing Office). The initial agreement was approved on April 21, 2015, in the not-to-exceed amount of \$1,100,000.

NOW THEREFORE,

Contract #5725, Exhibit A, “Special Terms and Conditions” shall be amended as follows:

Total Contract Amount shall be amended as shown:

The contract for services shall not exceed \$375,000 over the contract term.
Pricing shall be per Exhibit E of the original contract.

All other provisions of the contract 5725 as heretofore amended, remain in full force and effect.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Denton (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you.
