AN ORDINANCE OF THE CITY OF DENTON, TEXAS, ESTABLISHING RATES AND FEES FOR CITY OWNED PROPERTY AND FACILITIES UPON DENTON ENTERPRISE AIRPORT; AND DECLARING AN EFFECTIVE DATE

WHEREAS, Denton Enterprise Airport operates under the guidance of the Federal Aviation Administration ("FAA") and the FAA recommends airports establish rates and fees associated with the use of airport land; and

WHEREAS, in accordance with City Code, any fee for the use of City property must be adopted by City Council; and

WHEREAS, the City Council finds that the fees imposed are in the public interest; NOW, THEREFORE,

## THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS

SECTION 1. The findings and recitations contained in the preamble of this ordinance are incorporated herein by reference.

<u>SECTION 2</u>. The charges for property and facilities upon Denton Enterprise Airport shall be as indicated in Exhibit 1, Airport Rates and Fees Scheduled, attached hereto; and

SECTION 3. The Airport Rates and Fees Schedule shall be updated from time to time to ensure Airport property and facilities are producing fair market value; and

SECTION 4. This ordinance shall become effective immediately upon its passage and approval.
